Introduction

This report presents the developments in non-oil commodity exports and imports of the Kingdom of Saudi Arabia for the first quarter of 2016 as compared to the same period of the previous year, 2015, according to the statistical methods and international standard classifications, mainly the Harmonized System (H.S).

It should be noted that the statistics presented in this report are preliminary and they may undergo some modifications in case of a data update.

Note: There might be some differences in the aggregates of numbers or percentages due to rounding.

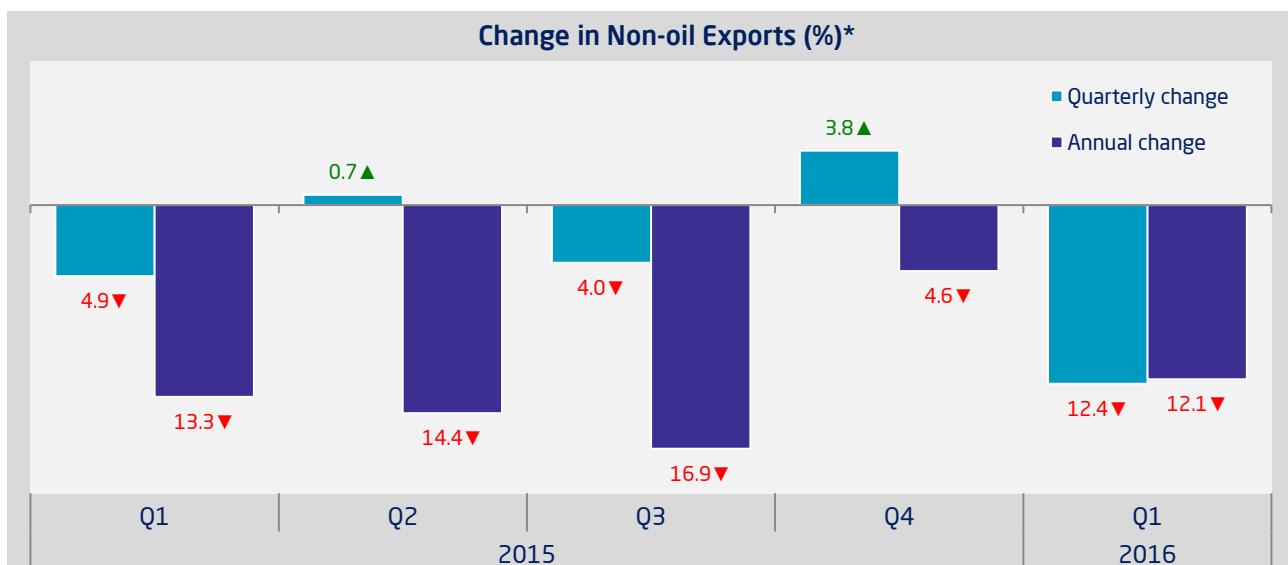
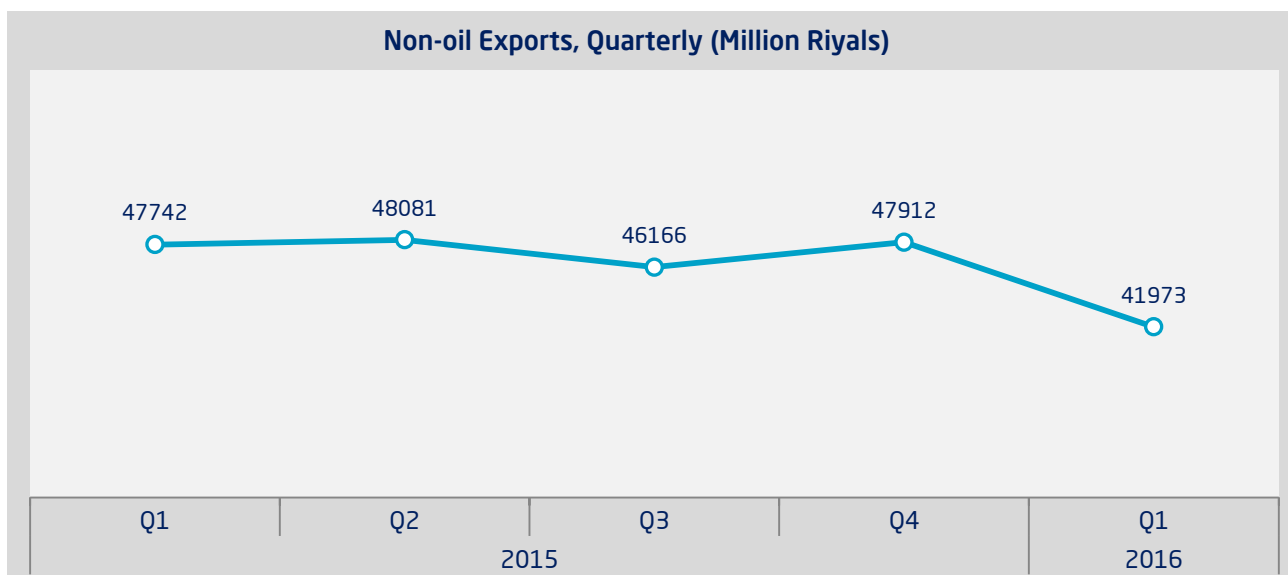


1. Non-oil Exports

1.1. Developments in Exports

Non-oil exports of Saudi Arabia amounted to 41973 million riyals in the first quarter (Q1) of 2016 as compared to 47742 million riyals in the corresponding period of the previous year, down by 5768 million riyals or 12.1%.

Non-oil exports in 2016Q1 were also lower than those in the preceding quarter (2015Q4) by 5939 million riyals or 12.4%.

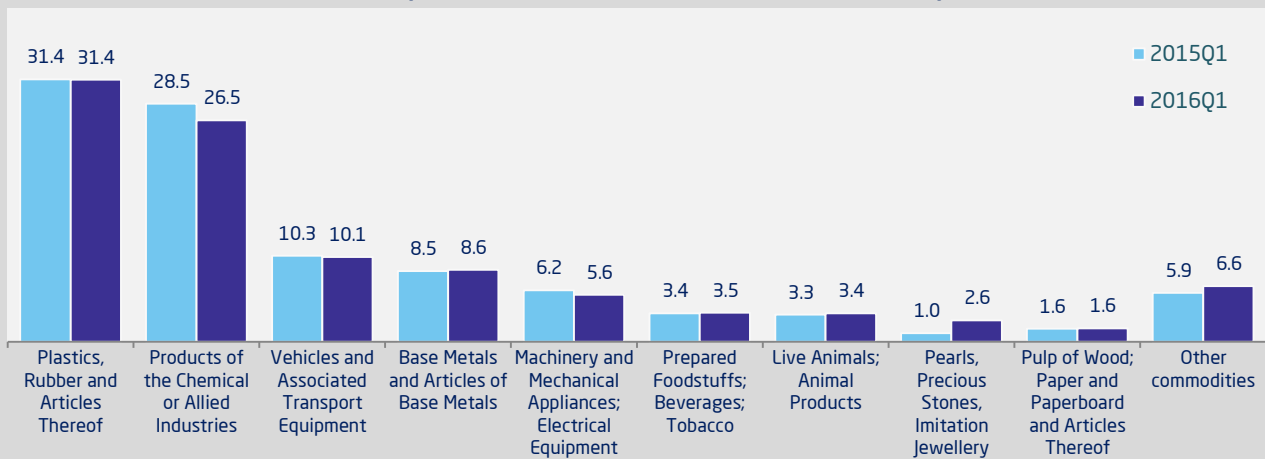

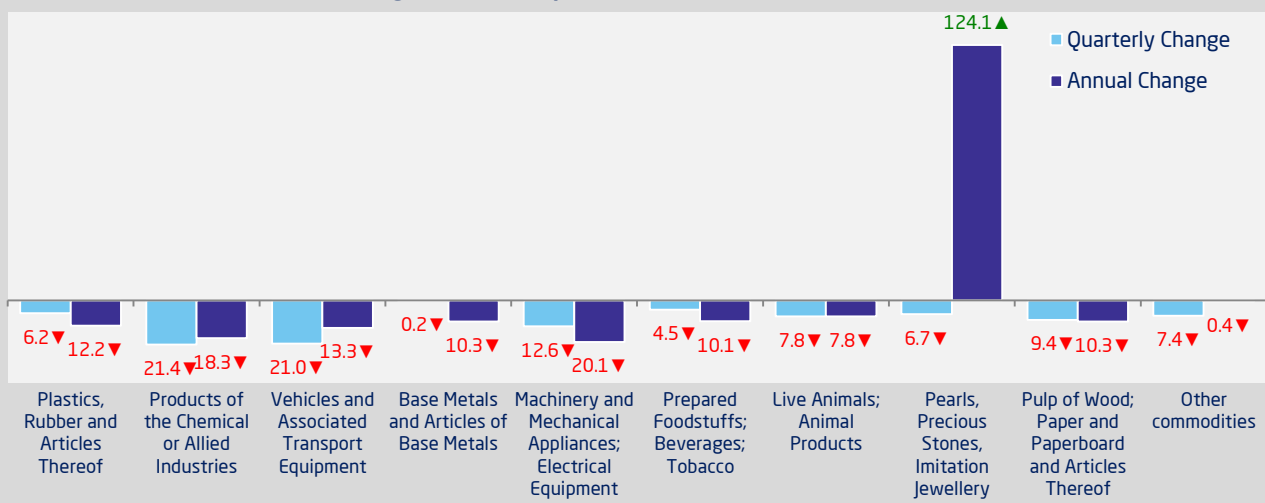

Change in Main Export Commodities, 2016Q1 (%)

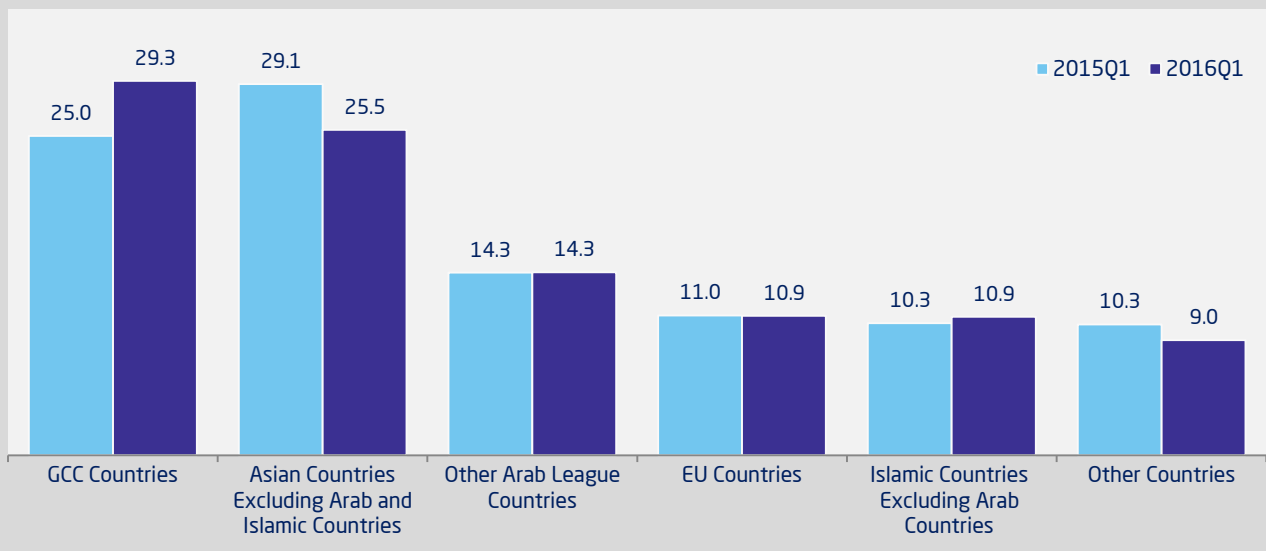




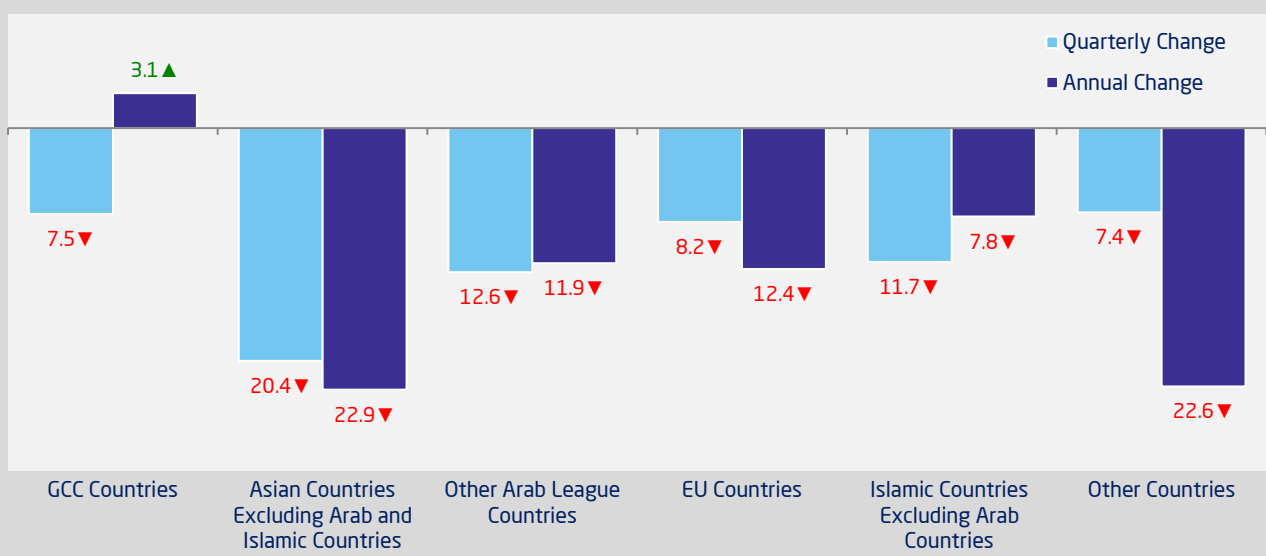

Change in Exports by Country Group, 2016Q1 (%)

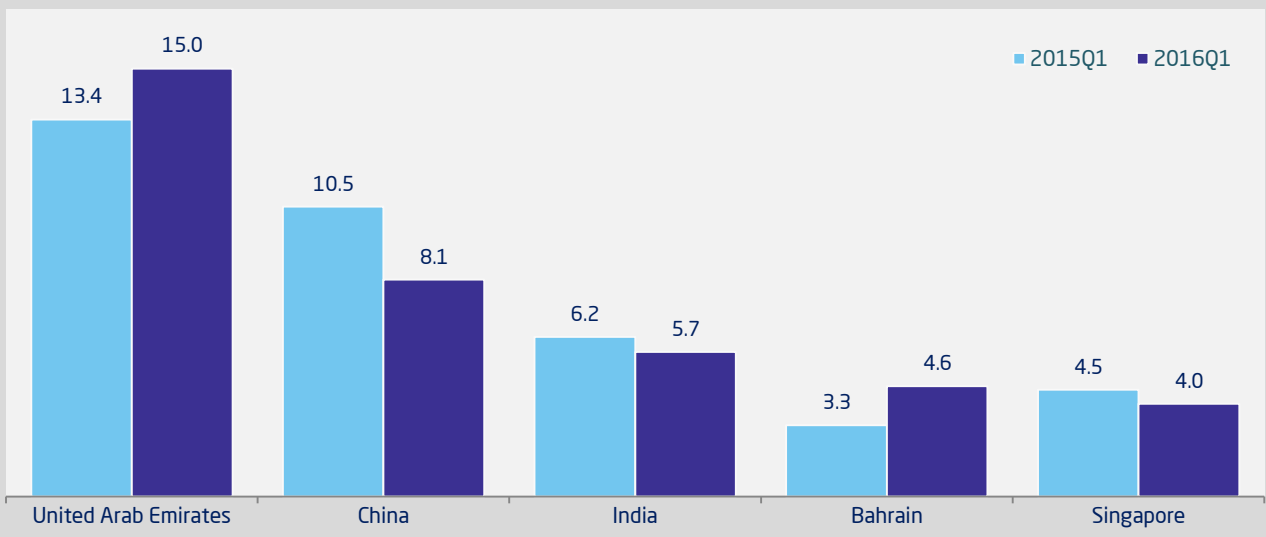




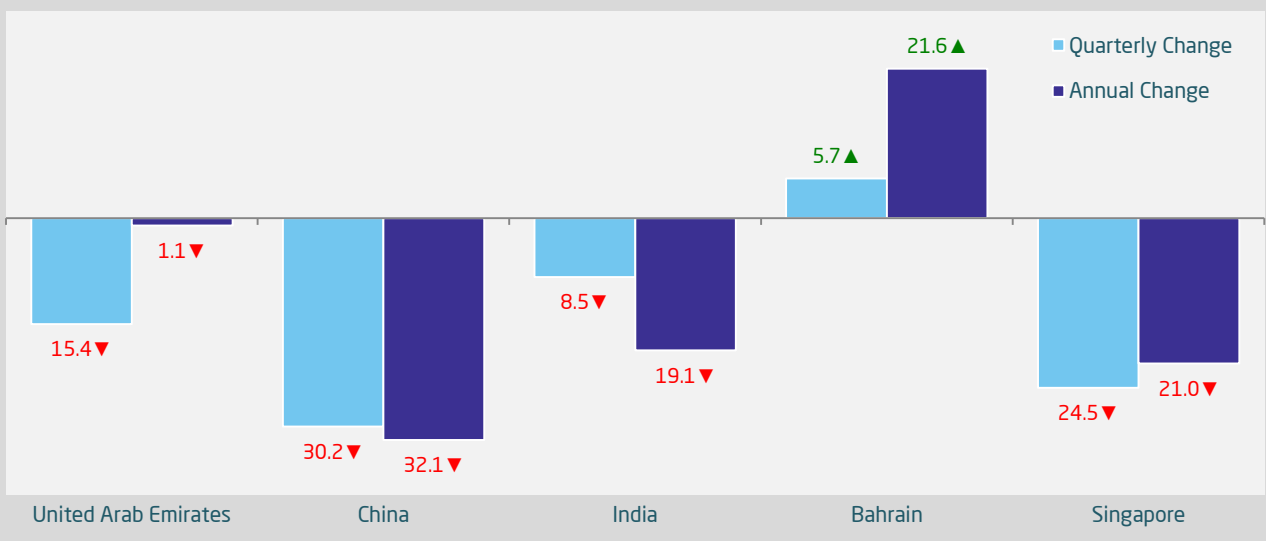

Change in Exports to Top 5 Countries, 2016Q1 (%)



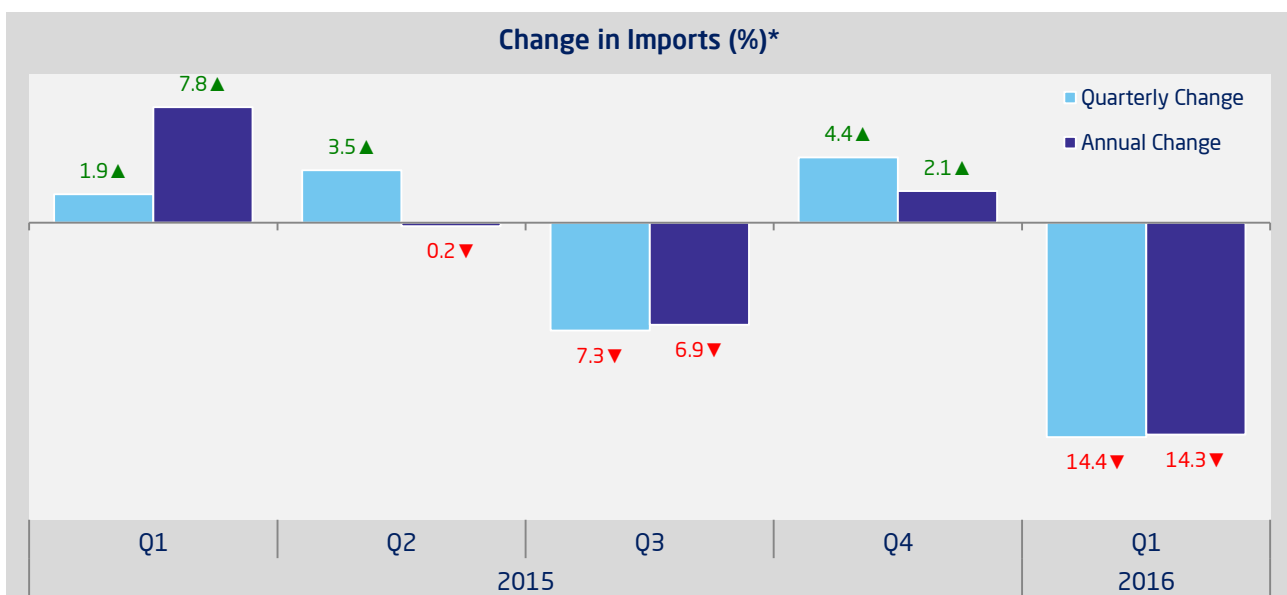
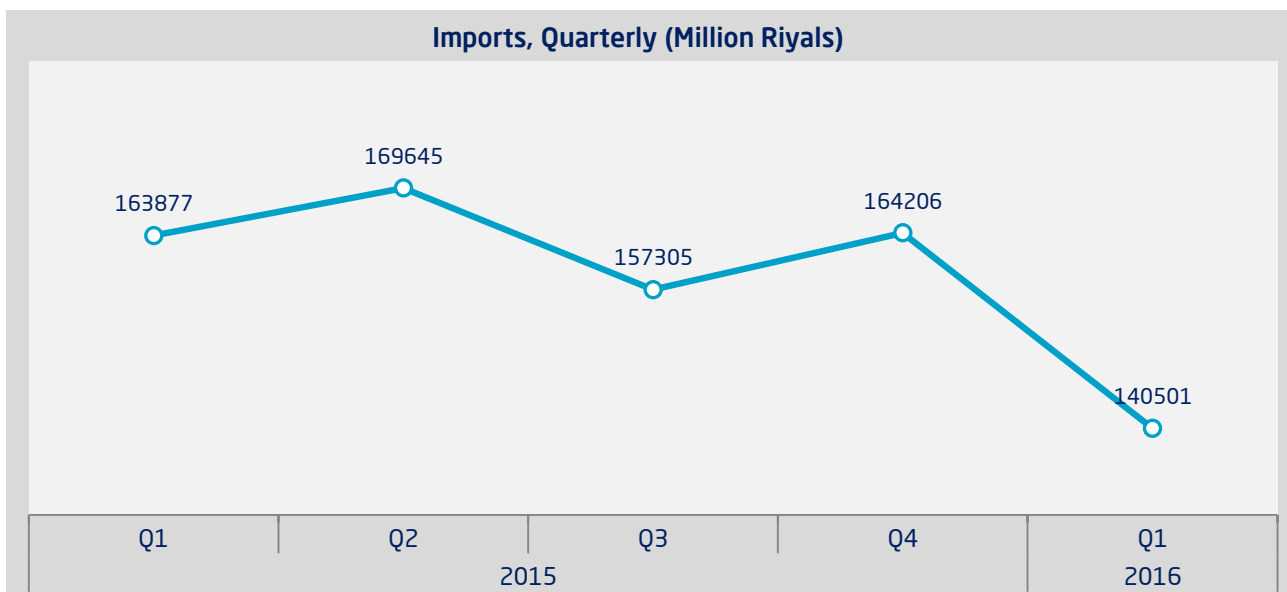


2. Imports

2.1. Developments in Imports

Total imports of Saudi Arabia amounted to 140501 million riyals in the first quarter (Q1) of 2016 as compared to 163877 million riyals in the corresponding period of the previous year, down by 23376 million riyals or 14.3%.

Imports in 2016Q1 were also lower than those in the preceding quarter (2015Q4) by 23704 million riyals or 14.4%.

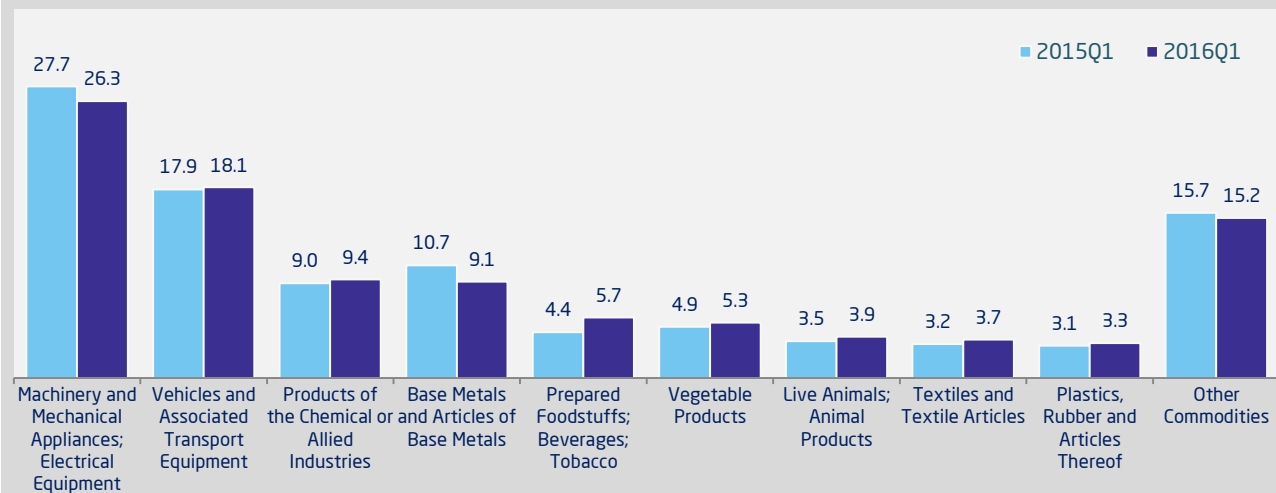

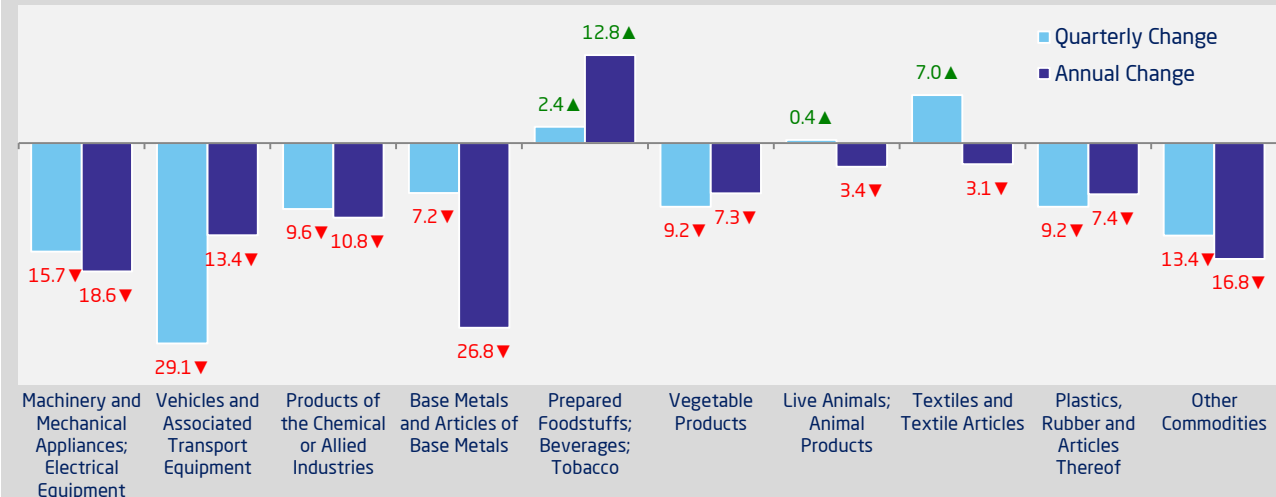

Main Import Commodities, 2016Q1 (Share in total imports, %)

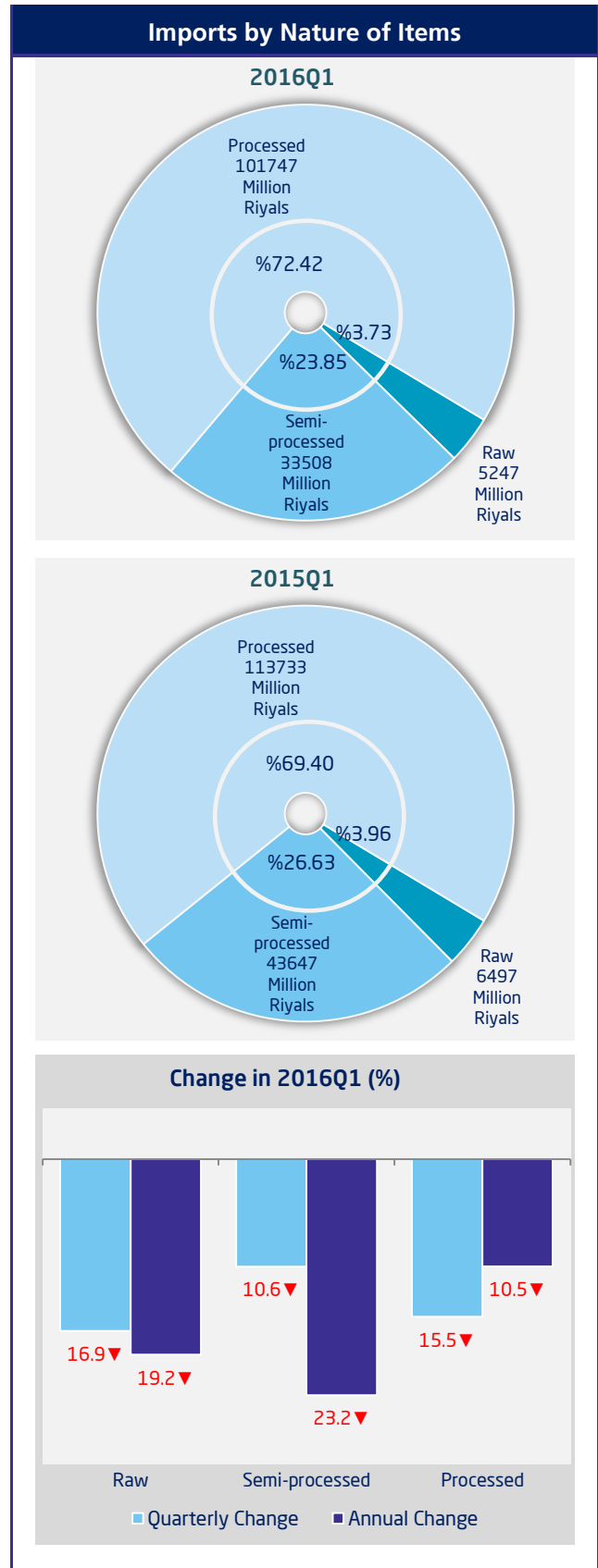
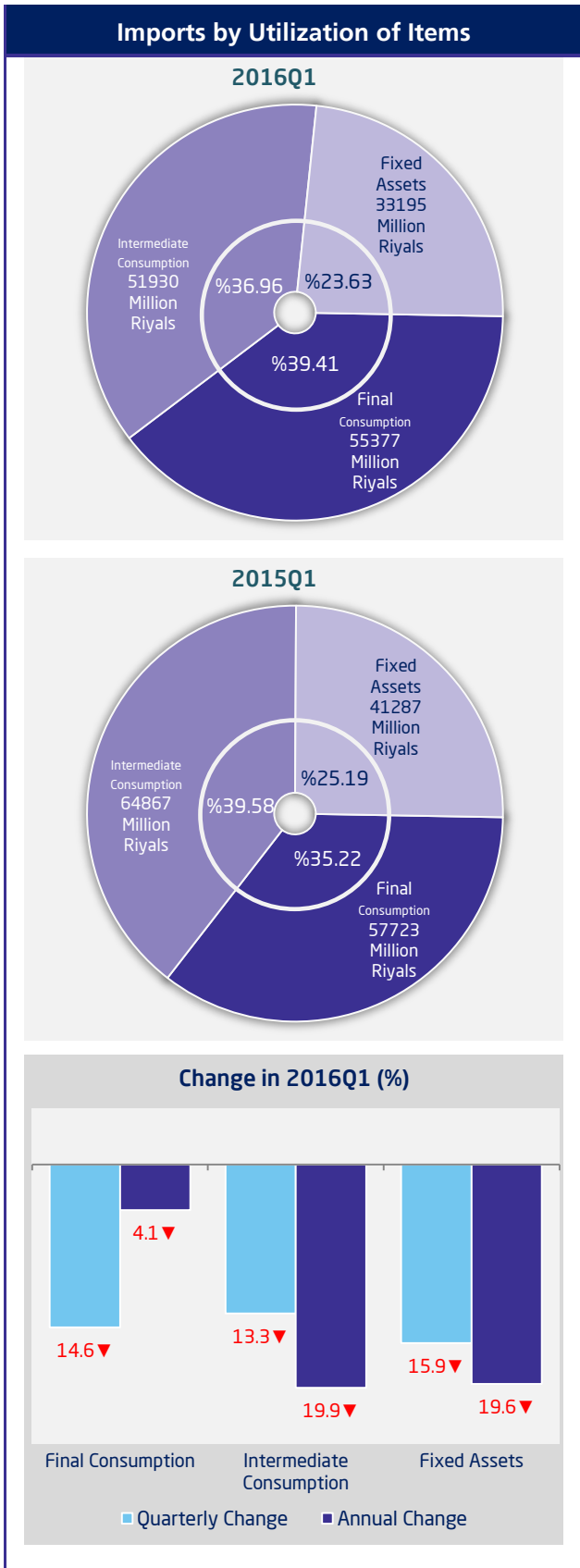


Change in Main Import Commodities, 2016Q1 (%)





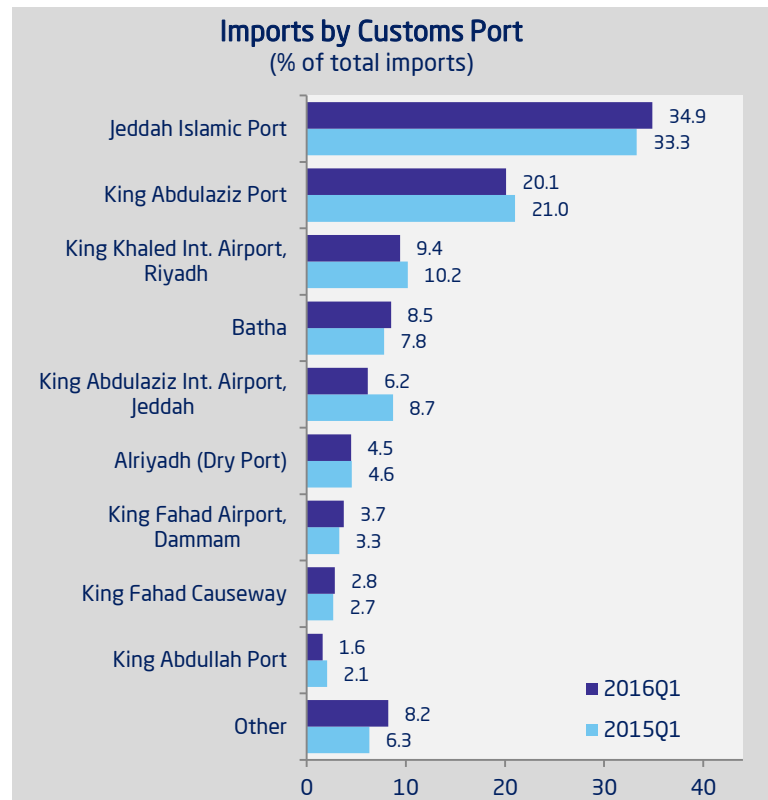

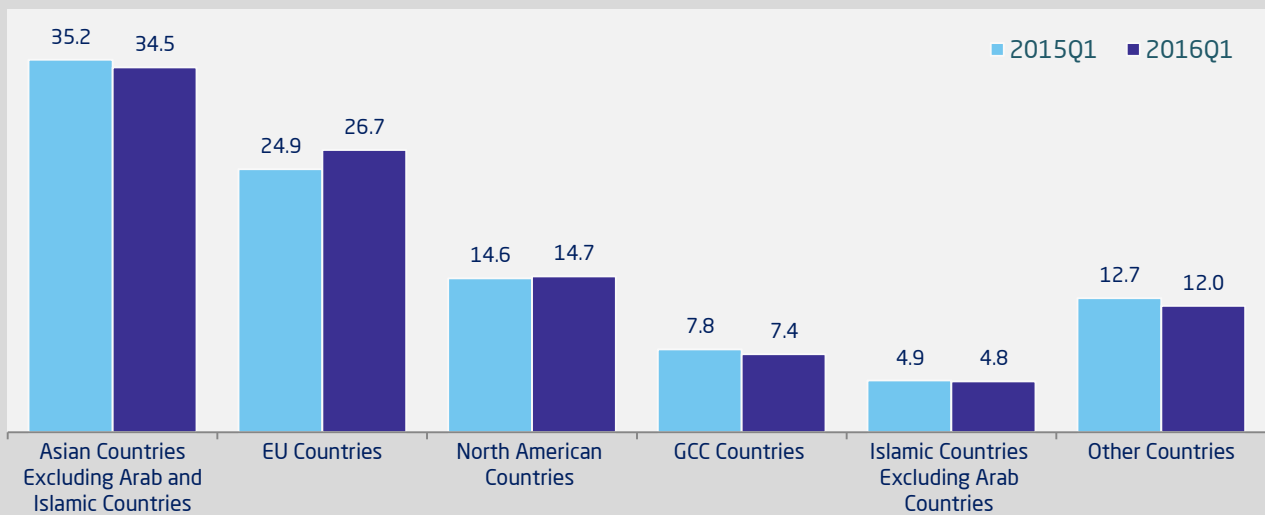




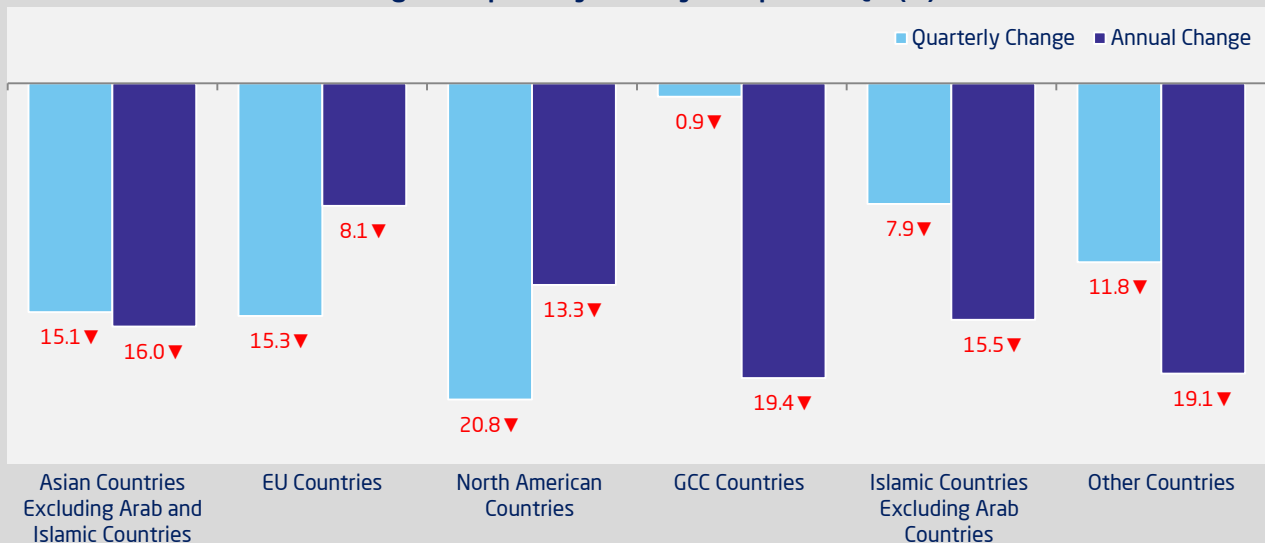

Change in Imports by Country Group, 2016Q1 (%)

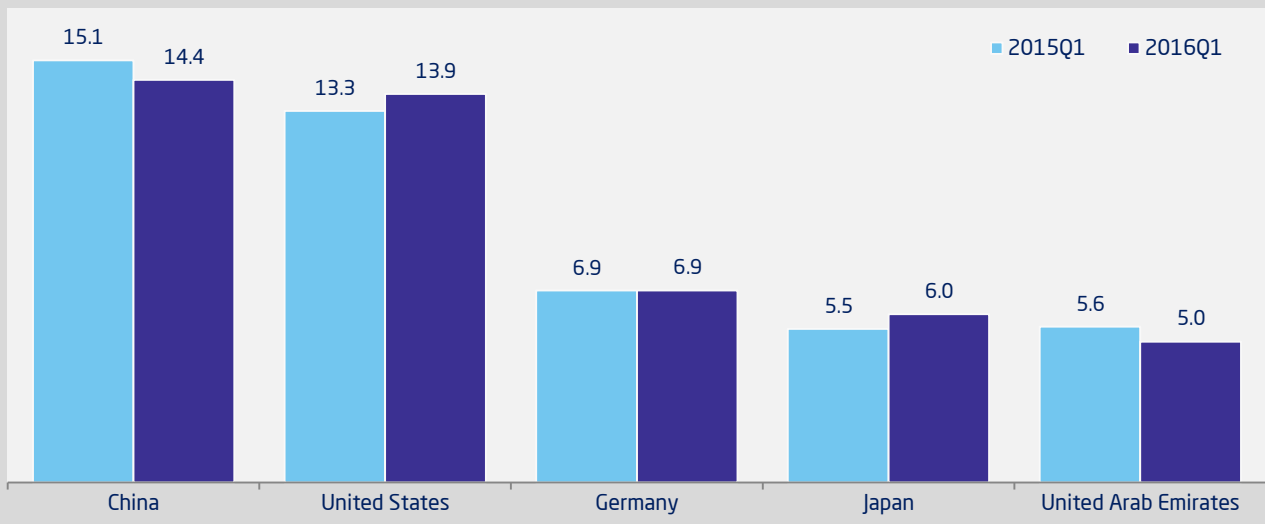




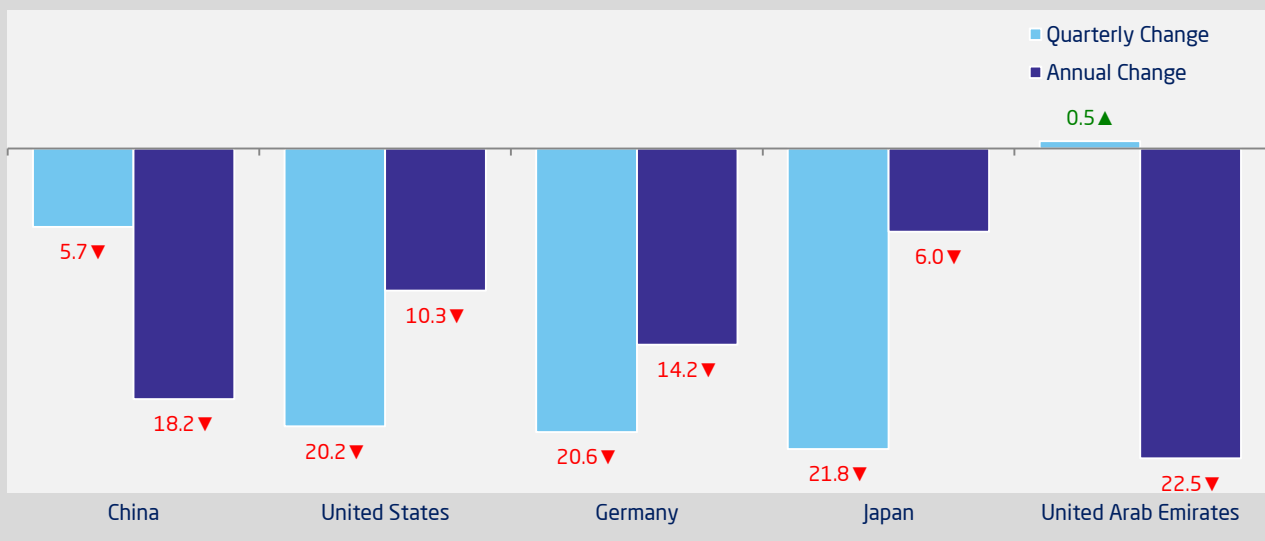

Change in Imports from Top 5 Countries, 2016Q1 (%)

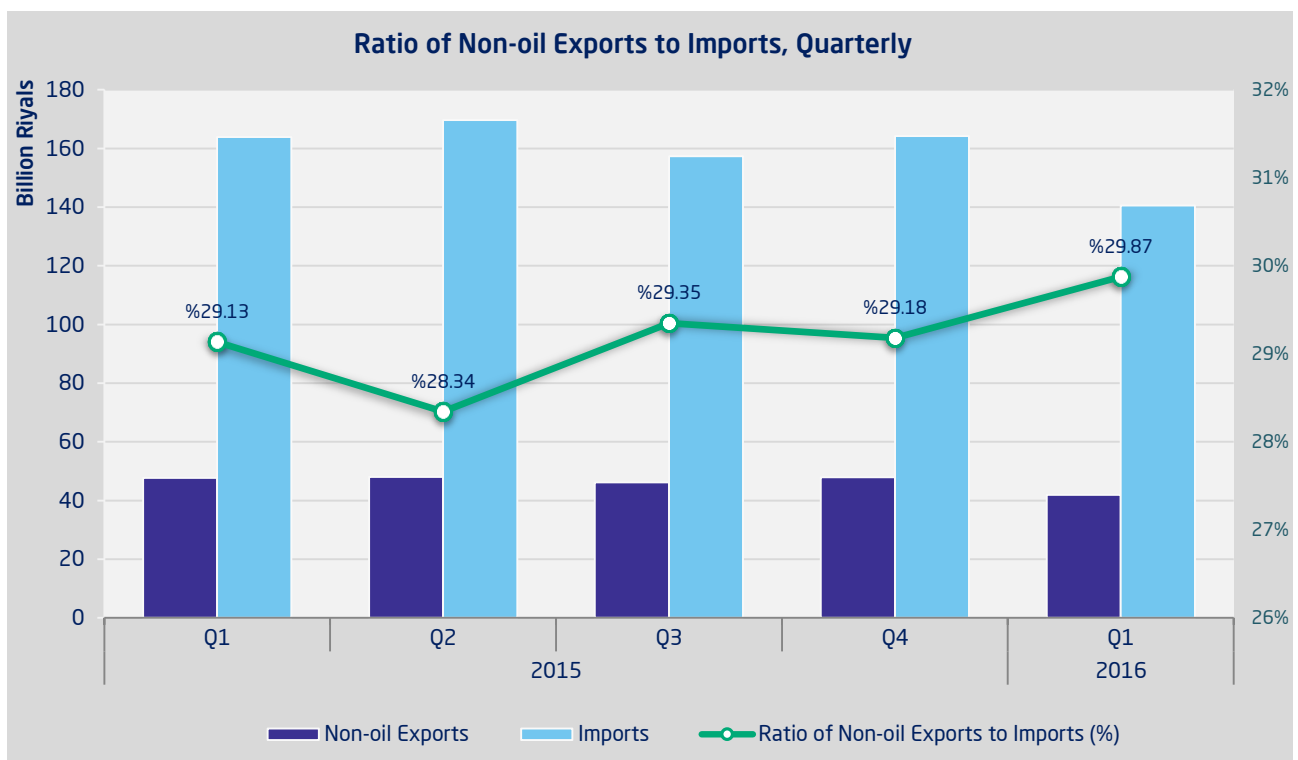




3. Ratio of Non-oil Exports to Imports, Quarterly

In the first quarter of 2016, non-oil exports amounted to 41973 million riyals and accounted for 29.87% of the imports. In the same period of the previous year, non-oil exports amounted to 47742 million riyals and accounted for 29.13% of the imports.

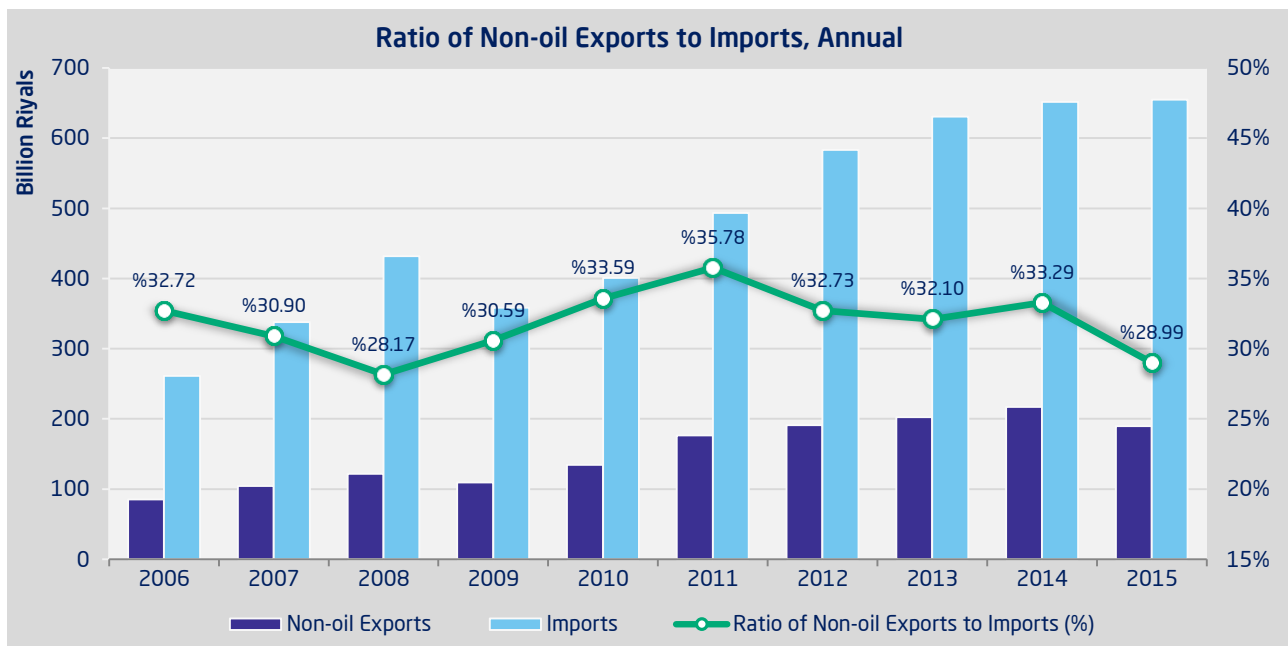




4. Ratio of Non-oil Exports to Imports, Annual

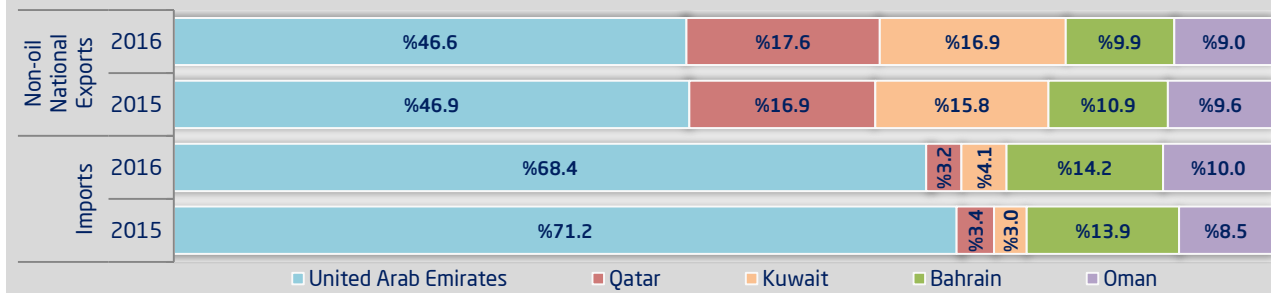
5. Trade between Saudi Arabia and GCC Countries

In the first quarter of 2016, non-oil exports of Saudi Arabia of national origin to GCC countries reached 7710 million riyals as compared to 7965 million riyals in the same period of the previous year, with a decrease of 255 million riyals corresponding to 3.2%. Saudi Arabia's imports of goods originated from GCC countries amounted to 10363 million riyals as compared to 12854 million riyals in the same period of the previous year, with a decrease of 2491 million riyals corresponding to 19.4%.

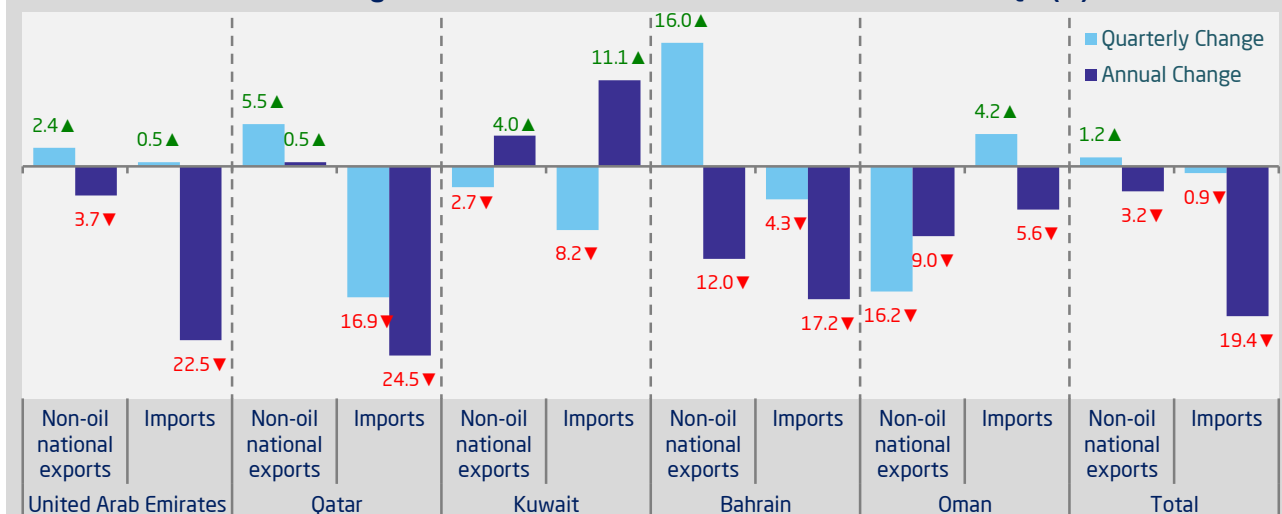
