

IPI decreases by 19.1% in April 2026

Preliminary results indicated a decrease of 19.1% in the Industrial Production Index (IPI) in April 2026 compared to the same month of the previous year (April 2025), affected by the decline in mining and quarrying activity and manufacturing activity. However, IPI decreased by 6.8% compared to March 2026.

Sub-index of mining and quarrying activity

In April 2026, the sub-index of mining and quarrying activity decreased by 29.9% compared to the same month of the previous year.

On a monthly basis, the sub-index of mining and quarrying activity decreased by 9.3%

Sub-index of manufacturing activity

Compared to April of the previous year, the sub-index of manufacturing activity decreased by 6.1%, affected by the decline in the manufacture of coke and refined petroleum products, which decreased by 18.7%, and the manufacture of chemicals and chemical products, which decreased by 4.2%

On a monthly basis, the sub-index of manufacturing activity showed a decrease of 4.8%, affected by the decline in the activity of the manufacture of coke and refined petroleum products, which decreased by 6.1%, and manufacture of chemicals and chemical products, which decreased by 9.7%

Sub-index of electricity, gas, steam, and air conditioning supply, and sub-index of water supply, sewage and waste management and remediation activities

The sub-index of electricity, gas, steam, and air conditioning supply activity recorded an annual increase of 20.8%, and the sub-index of water supply, sewerage and waste management and remediation activities increased by 8.8%

Based on the month-on-month trend, the sub-index of electricity, gas, steam, and air conditioning supply activity increased by 4.5%, and the sub-index of water supply, sewerage and waste management and remediation activities increased by 4.7%

IPI by main economic activities

The index of oil activities in April 2026 decreased by 27.8% compared to the same month of the previous year, while the index of non-oil activities increased by 2.1%. The results also indicated that the index of oil activities decreased by 8.7% and the index of non-oil activities decreased by 3.2% compared to March 2026.

Figure1. General index and annual growth rates

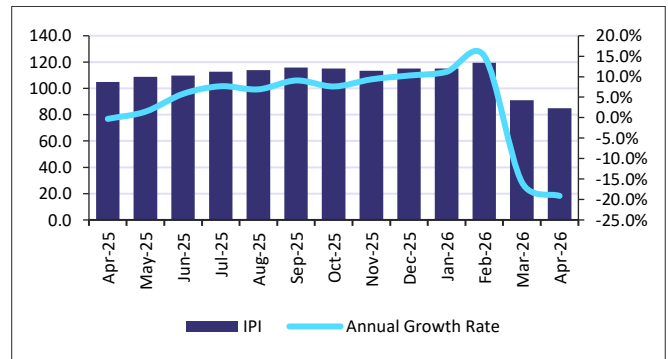


Figure 2. IPI according to ISIC4

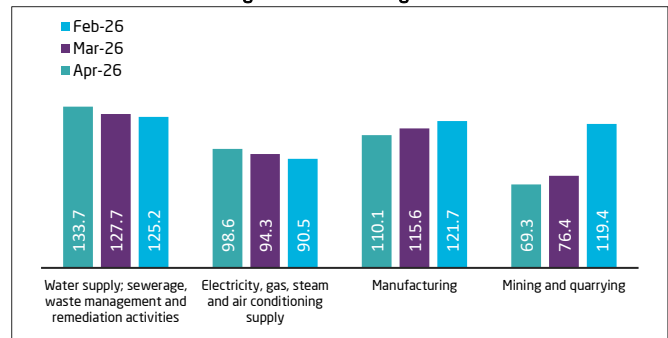


Figure 3. Annual growth rate of sub-indices according to ISIC4- April 2026

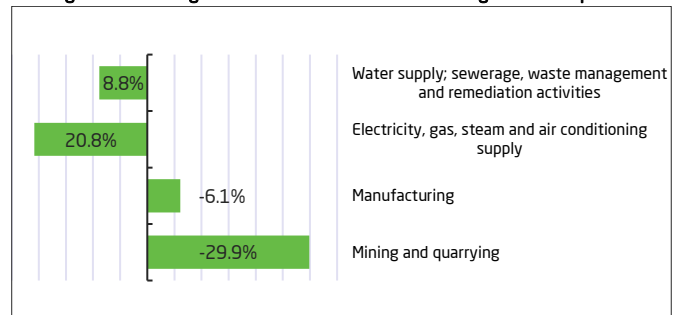
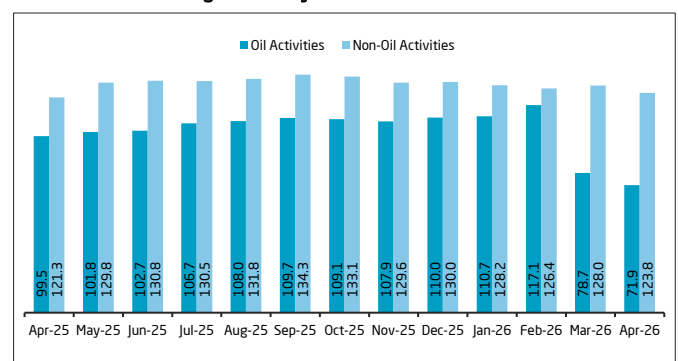


Figure 4. IPI by main economic activities



Methodology and quality

IPI is an economic indicator that reflects the relative changes in the volume of industrial production quantities, based on the Industrial Production Survey data. It is conducted on a sample of industrial establishments that operate in the targeted industrial activities, which are: mining and quarrying, manufacturing, electricity, gas, steam, and air conditioning supply, and water supply, sewerage and waste management and remediation activities. The data for this index, which is published on a monthly basis, is classified according to the National Classification of Economic Activities (ISIC 4).
