Introduction

This report presents the developments in non-oil commodity exports and imports of the Kingdom of Saudi Arabia for the second quarter of 2016 as compared to the same period of the previous year, 2015, according to the statistical methods and international standard classifications, mainly the Harmonized System (H.S).

It should be noted that the statistics presented in this report are preliminary and they may undergo some modifications in case of a data update.

Note: There might be some differences in the aggregates of numbers or percentages due to rounding.

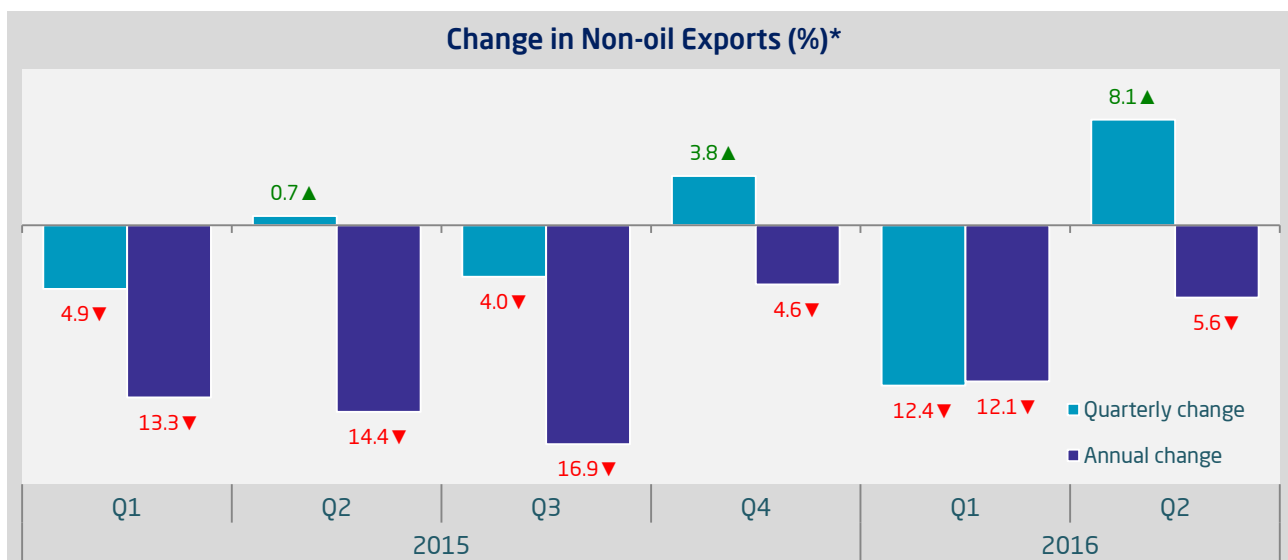
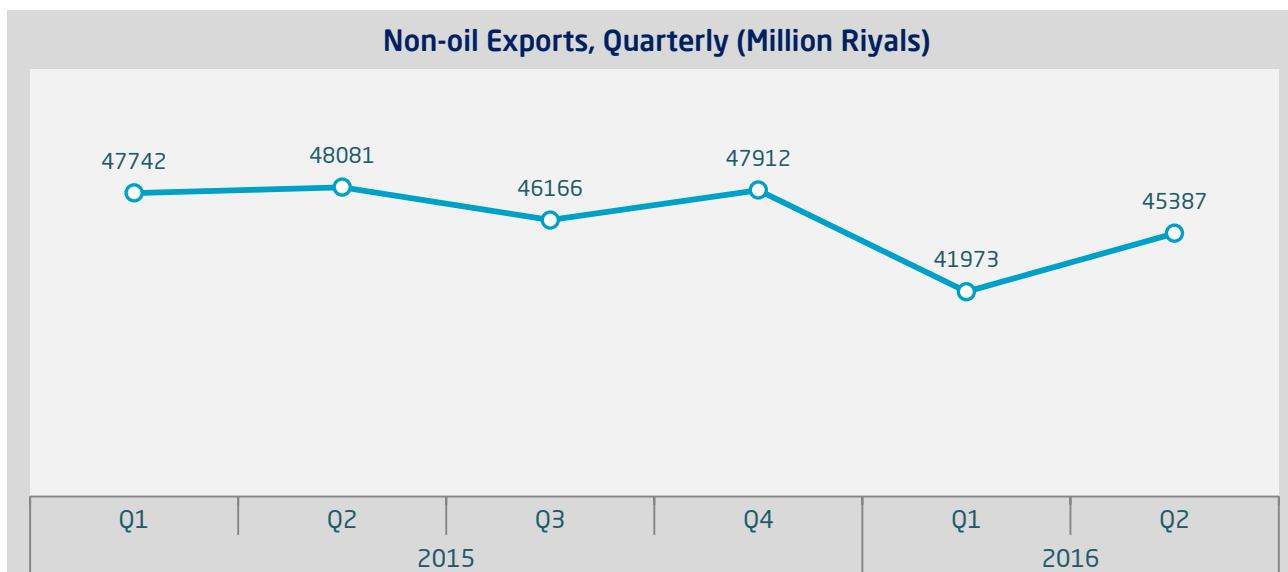


1. Non-oil Merchandise Exports

1.1. Developments in Exports

Non-oil exports of Saudi Arabia amounted to 45387 million riyals in the second quarter (Q2) of 2016 as compared to 48081 million riyals in the corresponding period of the previous year, down by 2694 million riyals or 5.6%.

Non-oil exports in 2016Q2 were higher than those in the preceding quarter (2016Q1) by 3415 million riyals or 8.1%.

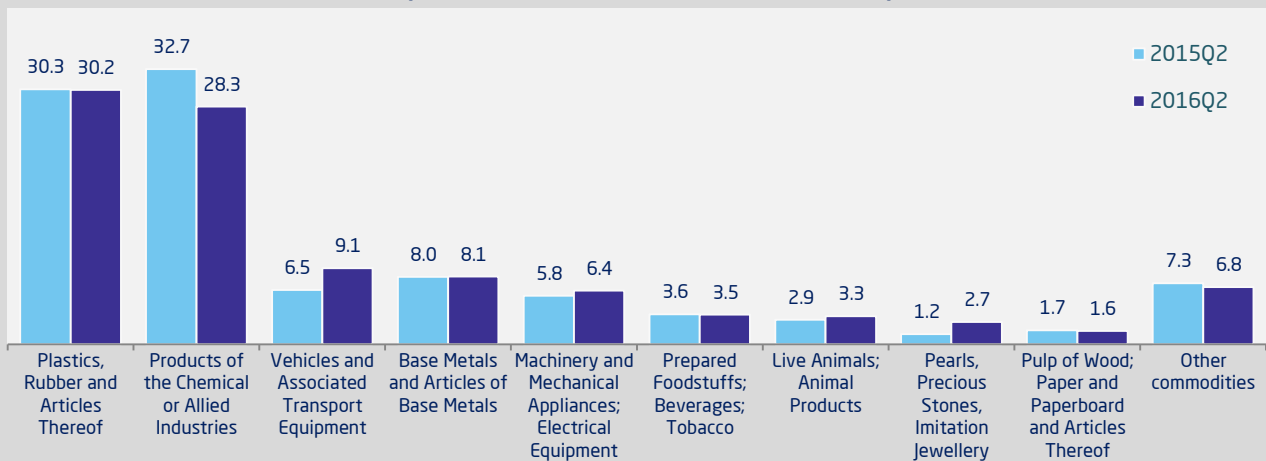

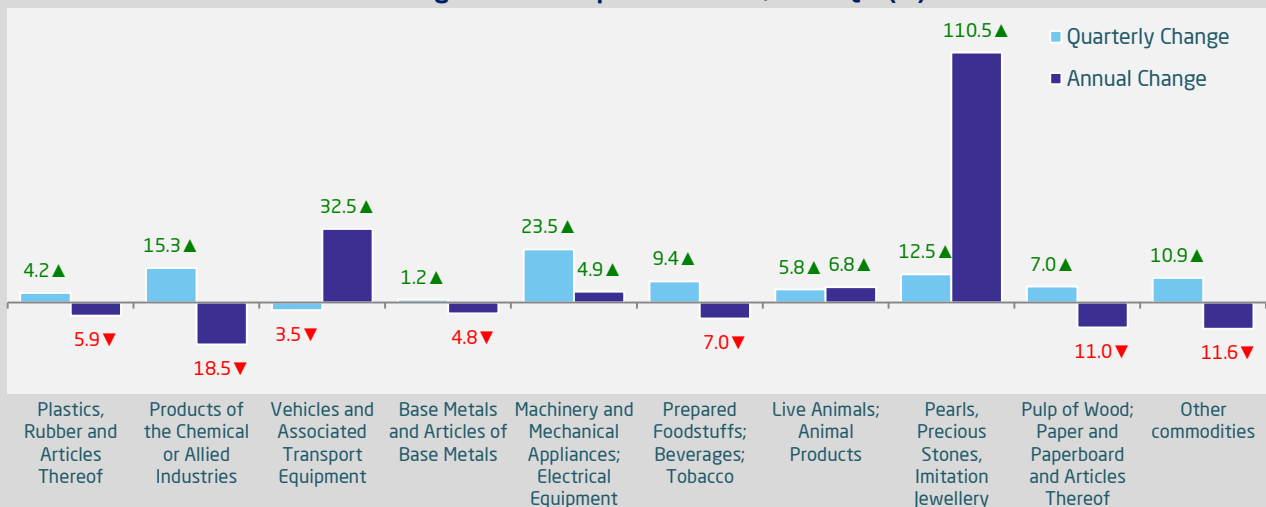

Change in Main Export Products, 2016Q2 (%)

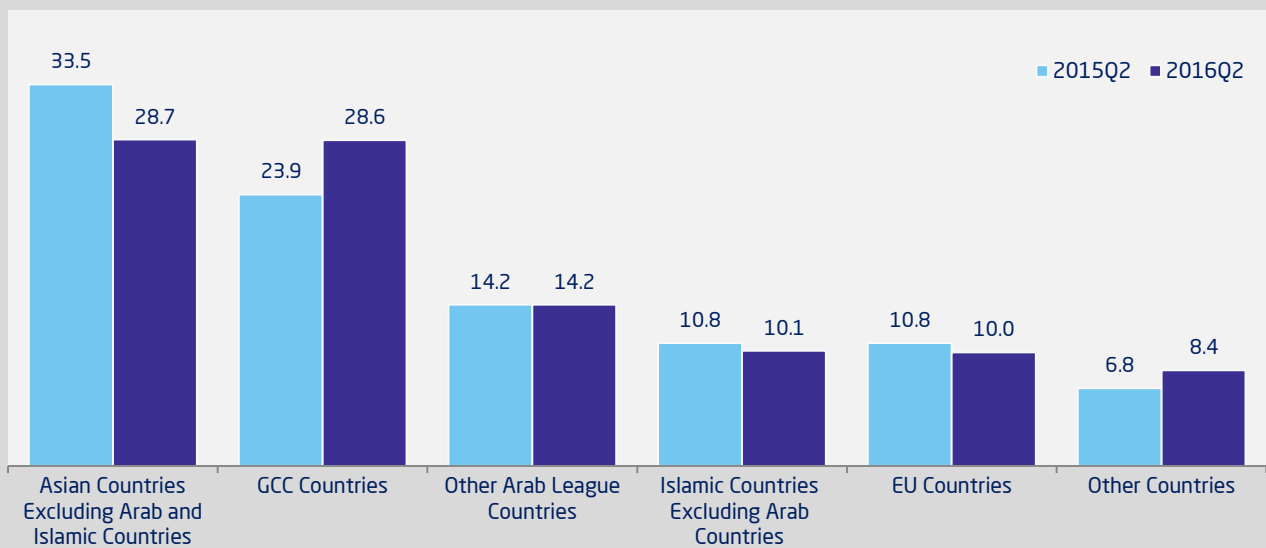




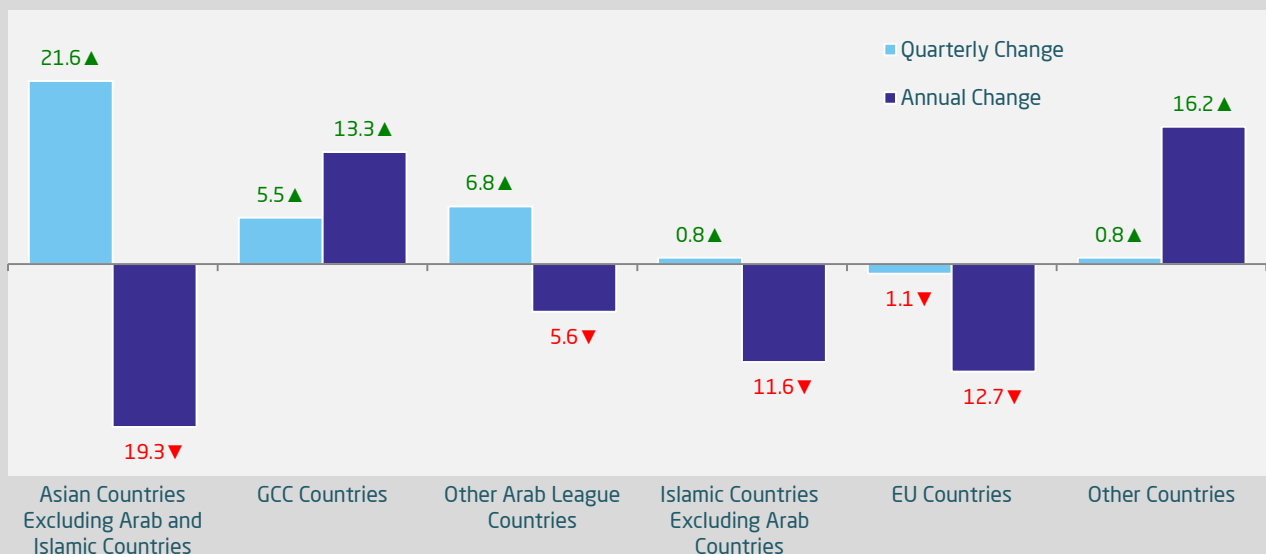

Change in Exports by Country Group, 2016Q2 (%)

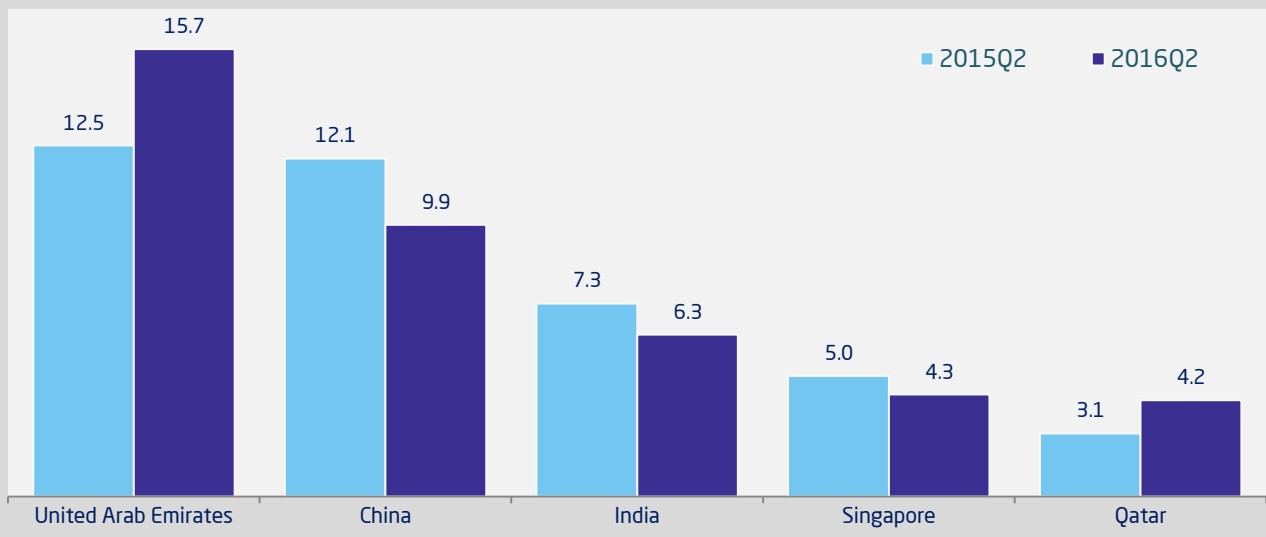




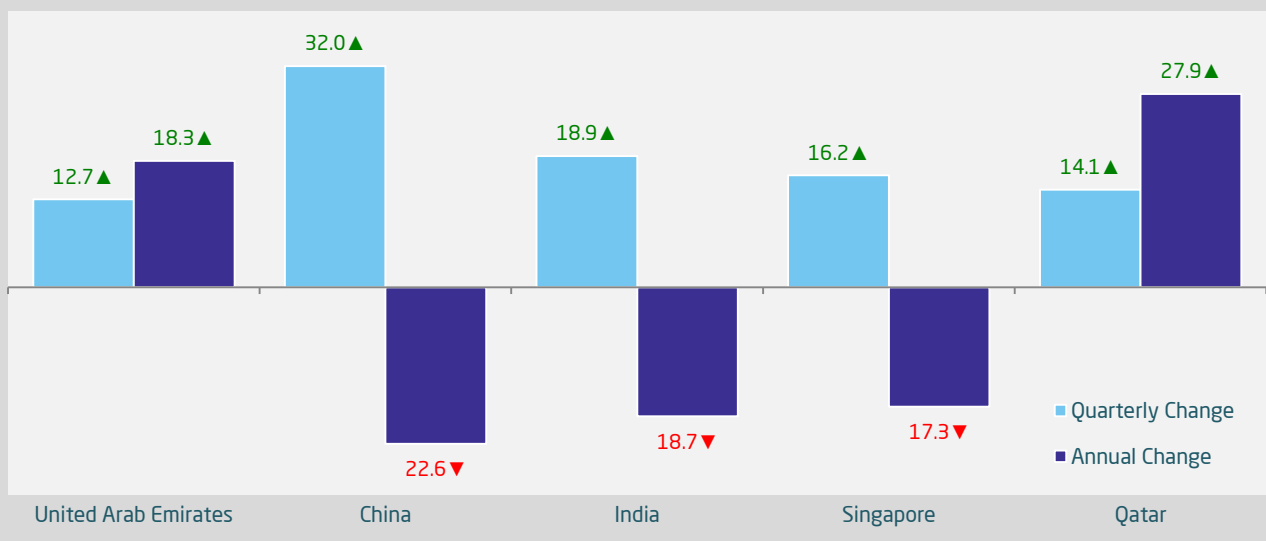

Change in Exports to Top 5 Countries, 2016Q2 (%)



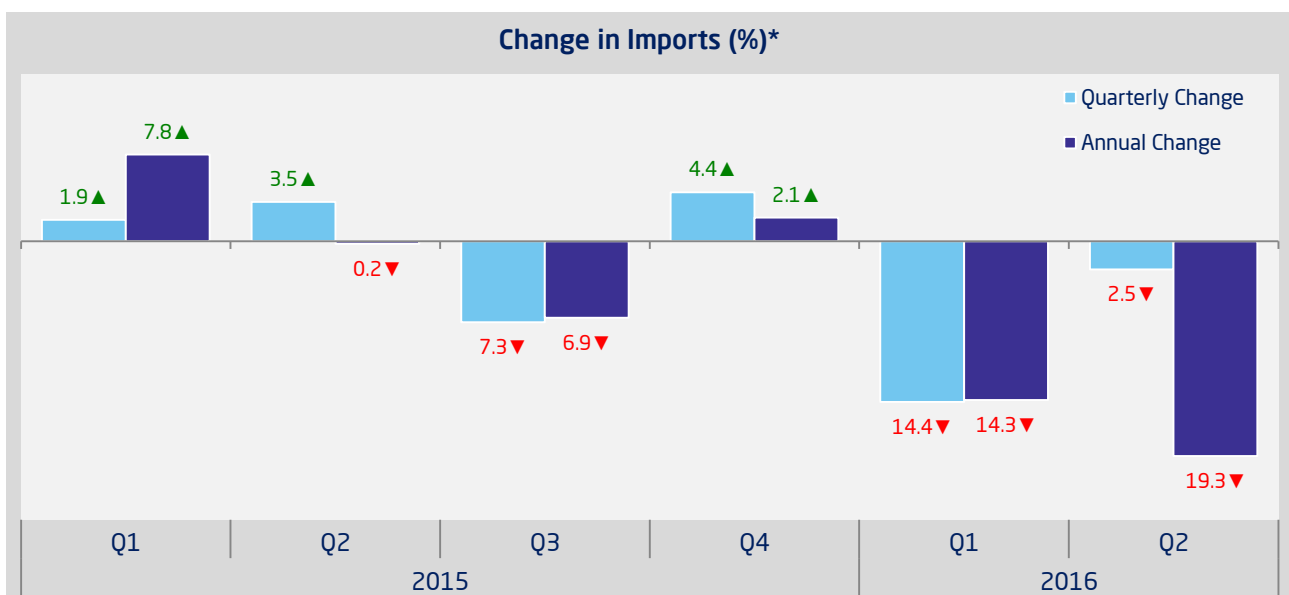
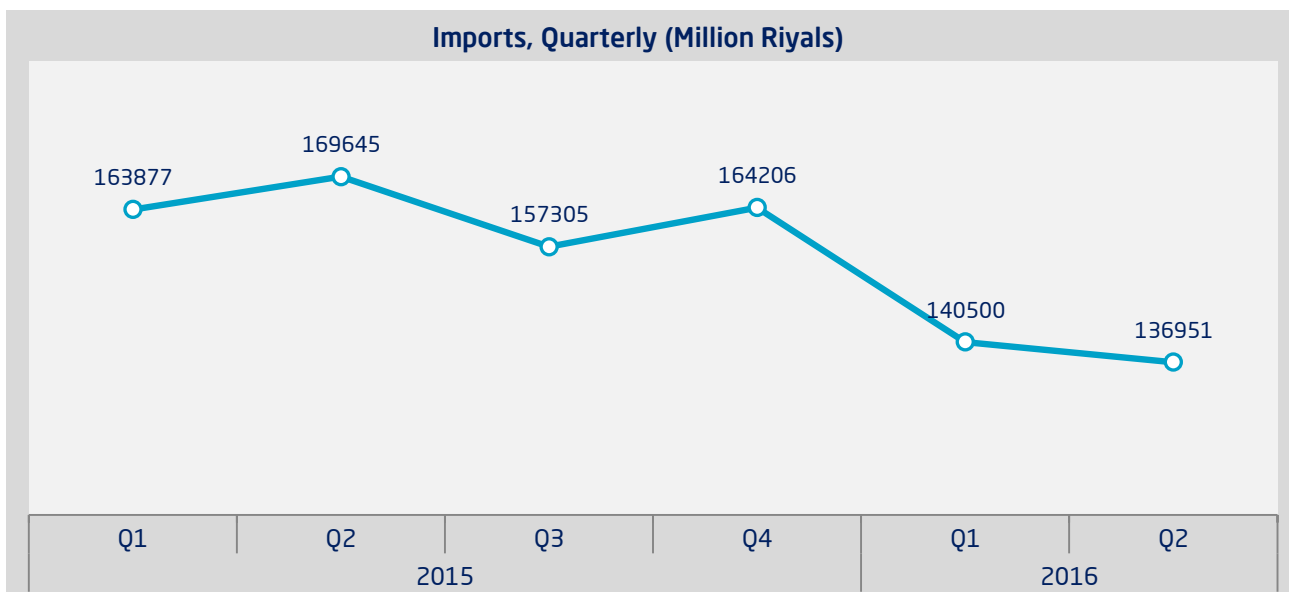


2. Merchandise Imports

2.1. Developments in Imports

Total imports of Saudi Arabia amounted to 136951 million riyals in the second quarter (Q2) of 2016 as compared to 169645 million riyals in the corresponding period of the previous year, down by 32694 million riyals or 19.3%.

Imports in 2016Q2 were also lower than those in the preceding quarter (2016Q1) by 3550 million riyals or 2.5%.

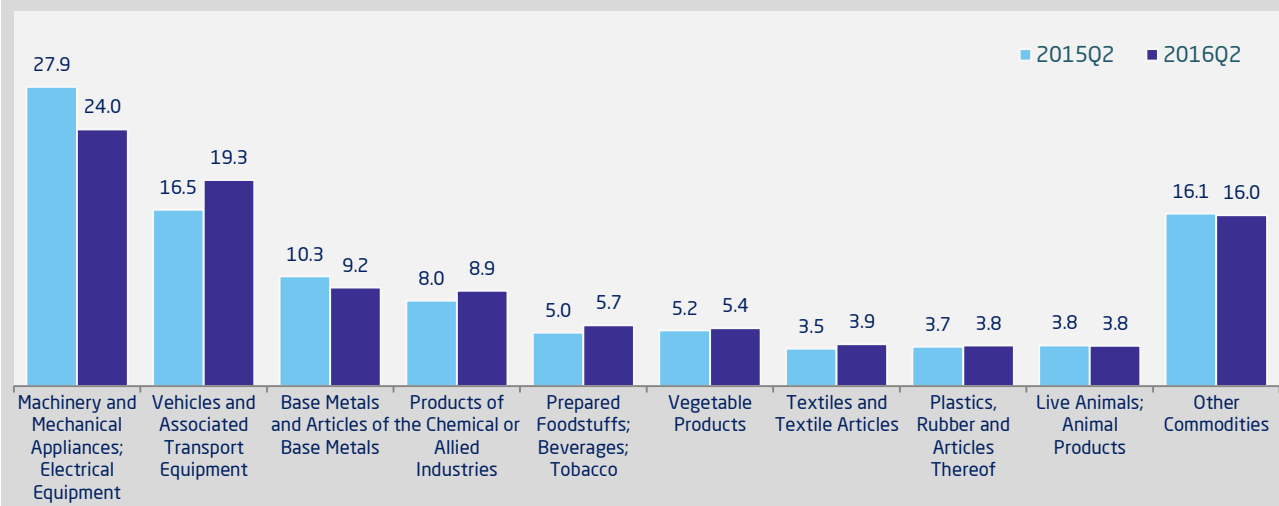

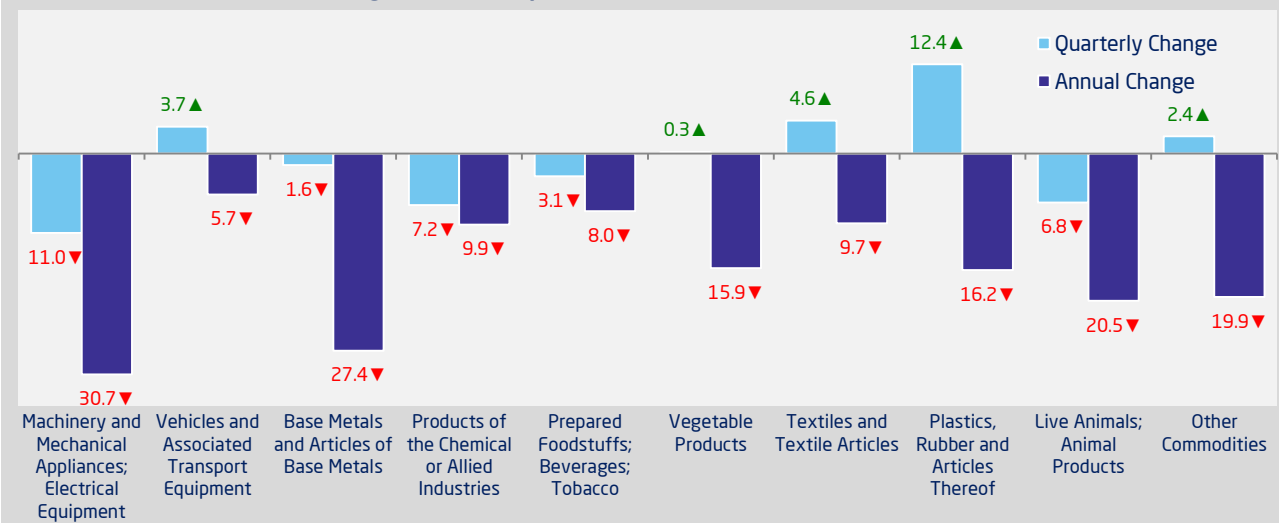

Main Import Products, 2016Q2 (Share in total imports, %)

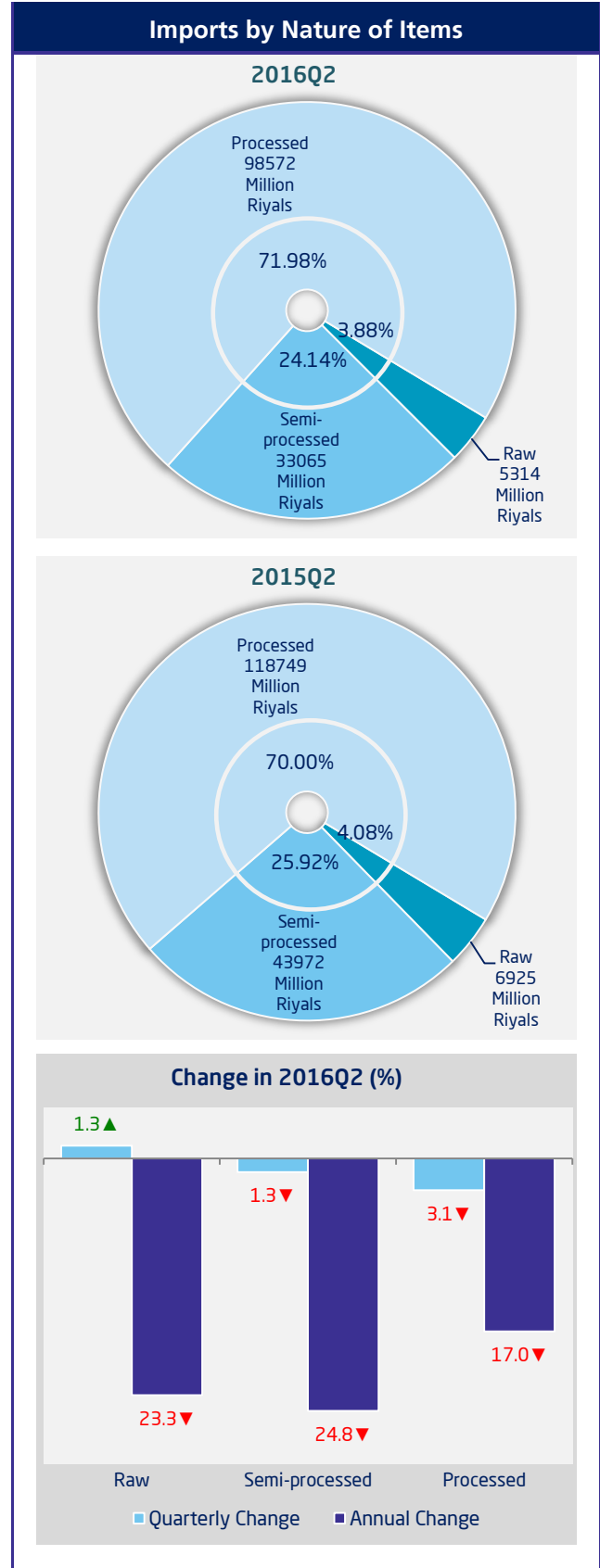
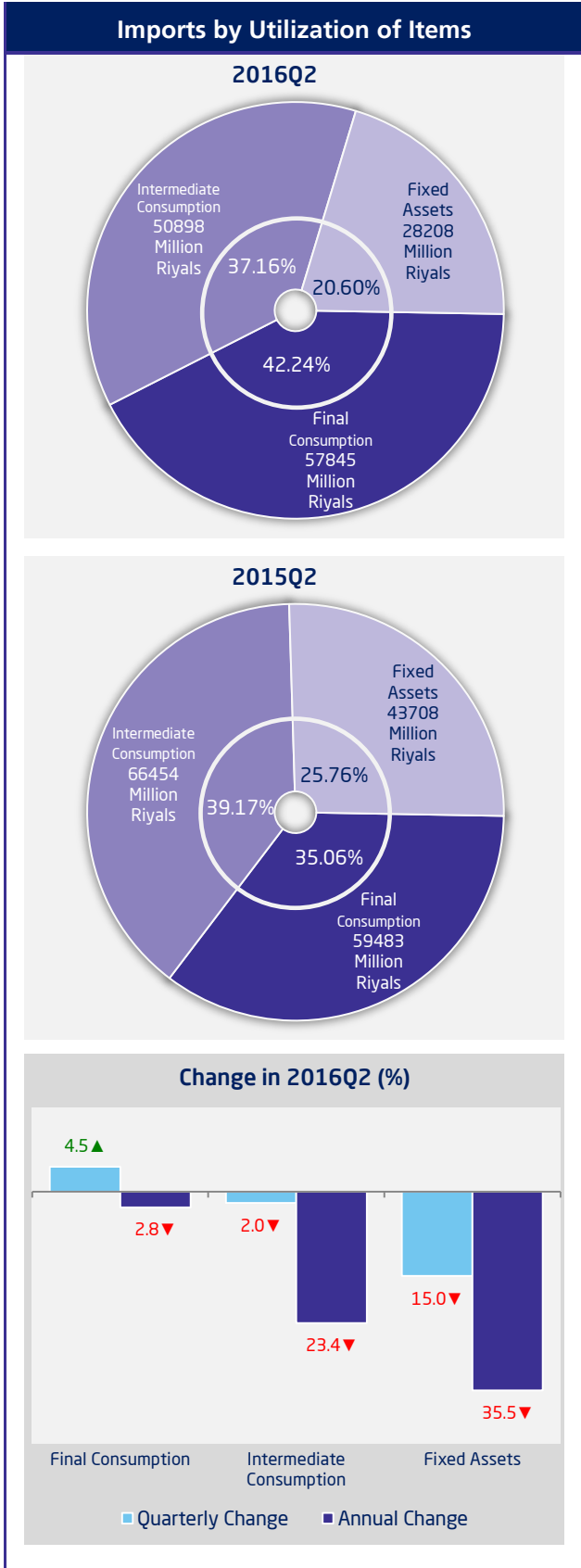


Change in Main Import Products, 2016Q2 (%)





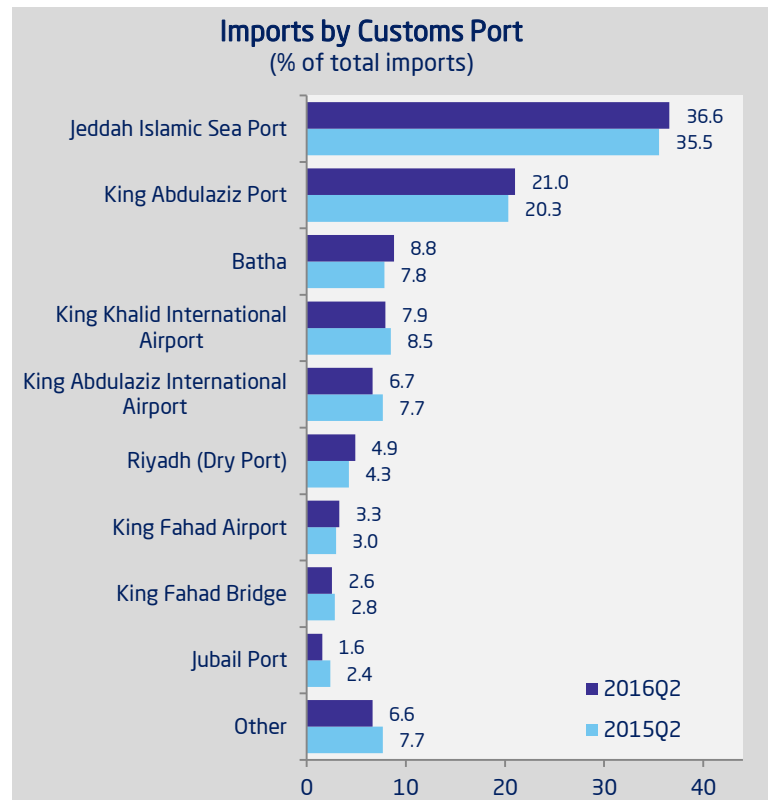

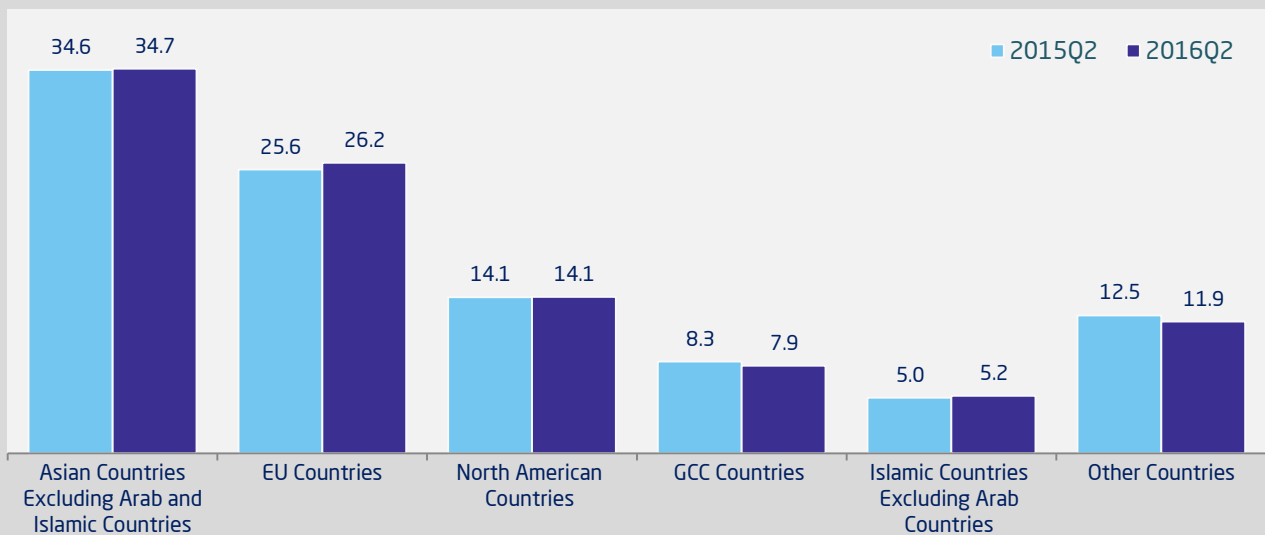




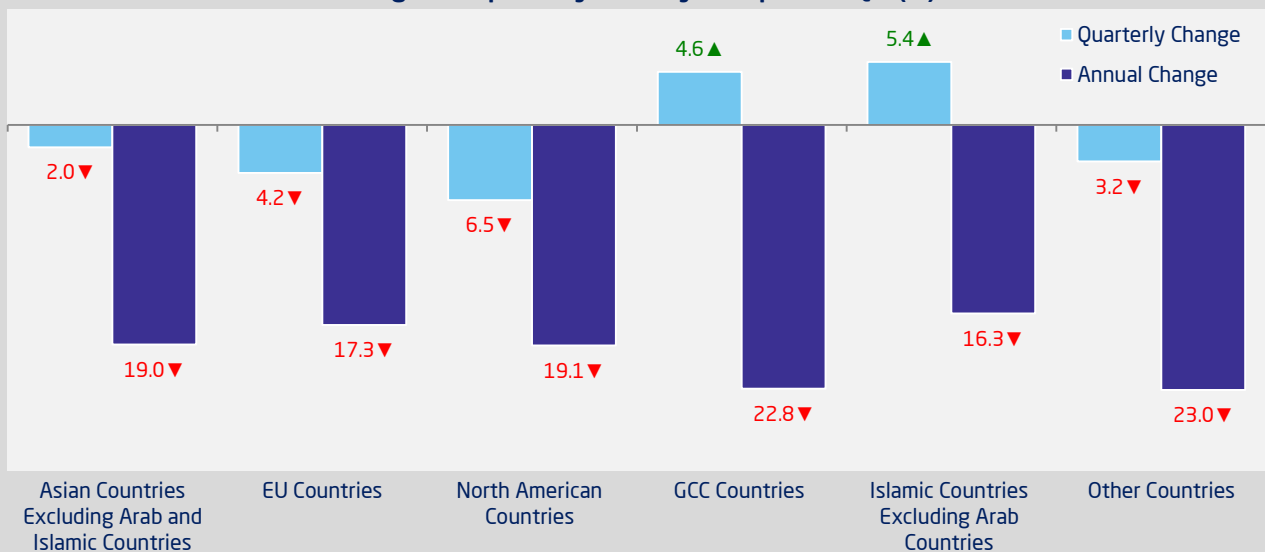

Change in Imports by Country Group, 2016Q2 (%)

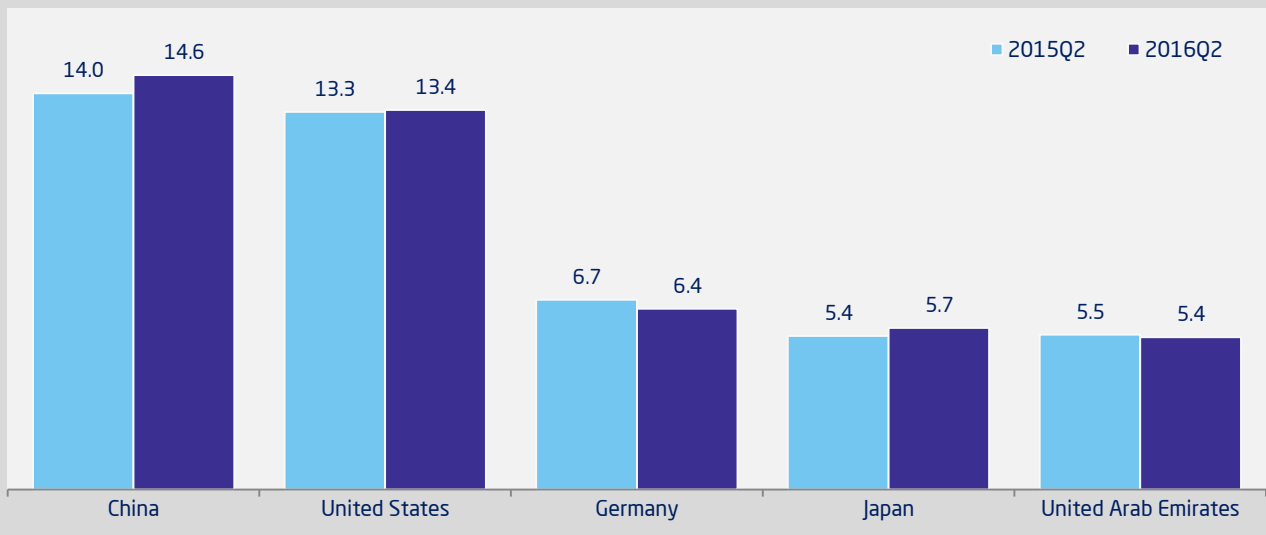




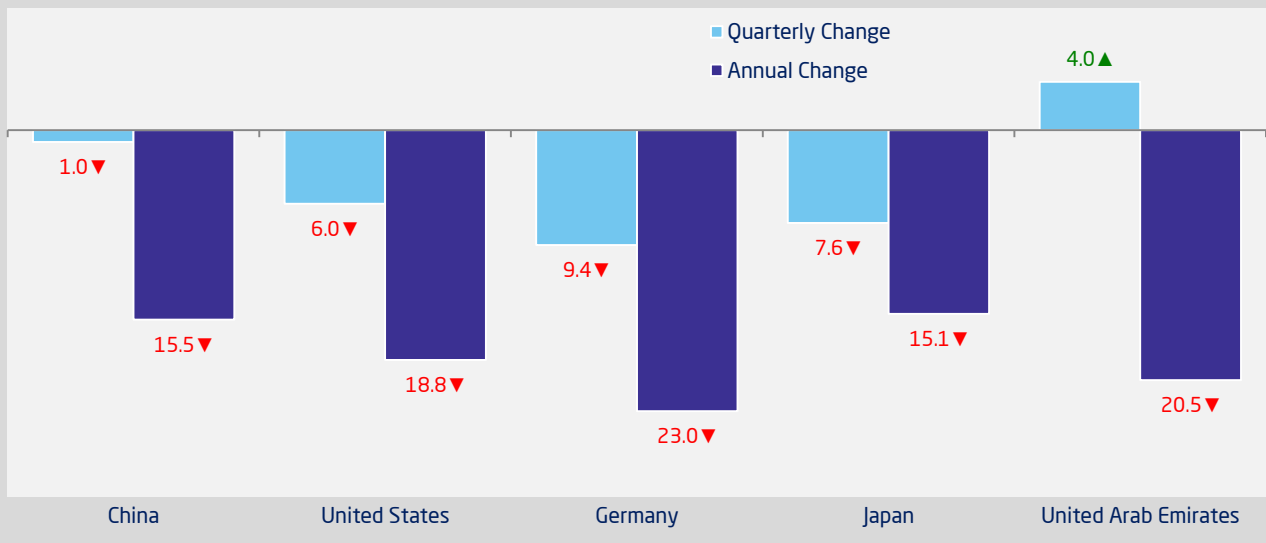

Change in Imports from Top 5 Countries, 2016Q2 (%)

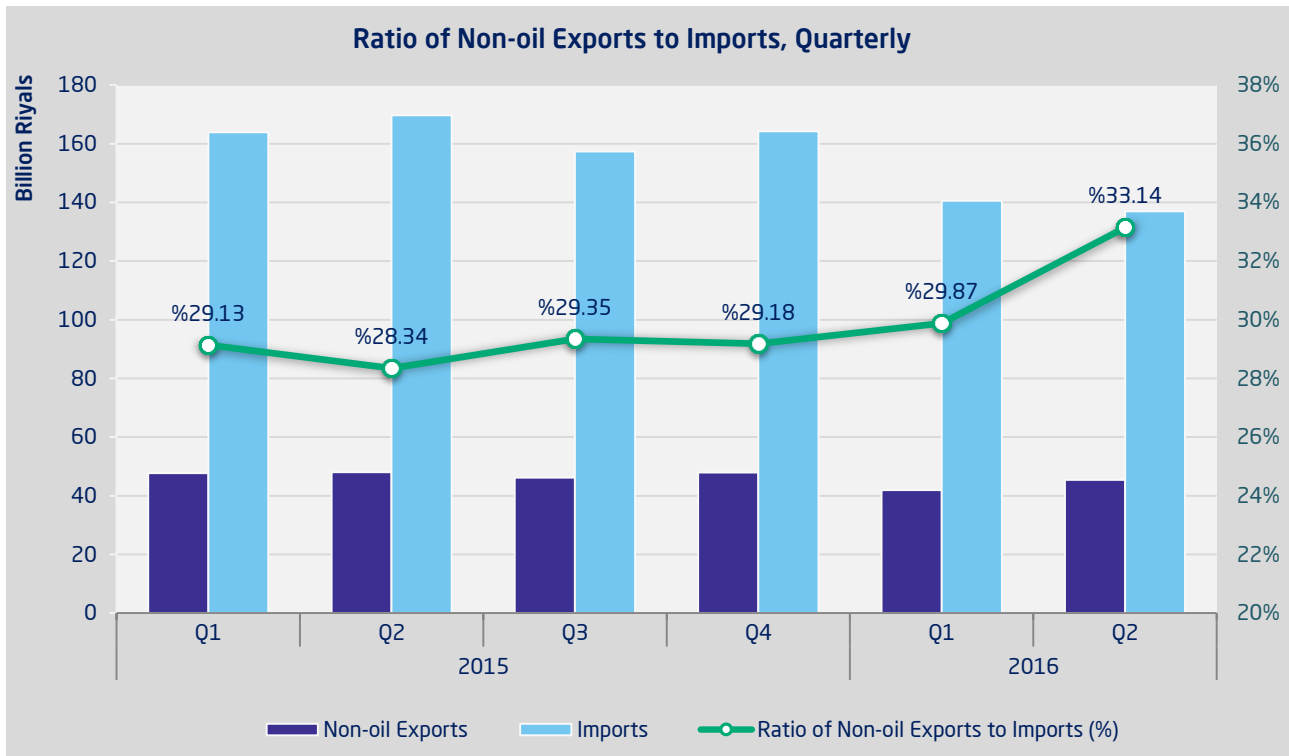




3. Ratio of Non-oil Exports to Imports, Quarterly

In the second quarter of 2016, non-oil exports amounted to 45387 million riyals and accounted for 33.14% of the imports. In the same period of the previous year, non-oil exports amounted to 48081 million riyals and accounted for 28.34% of the imports.

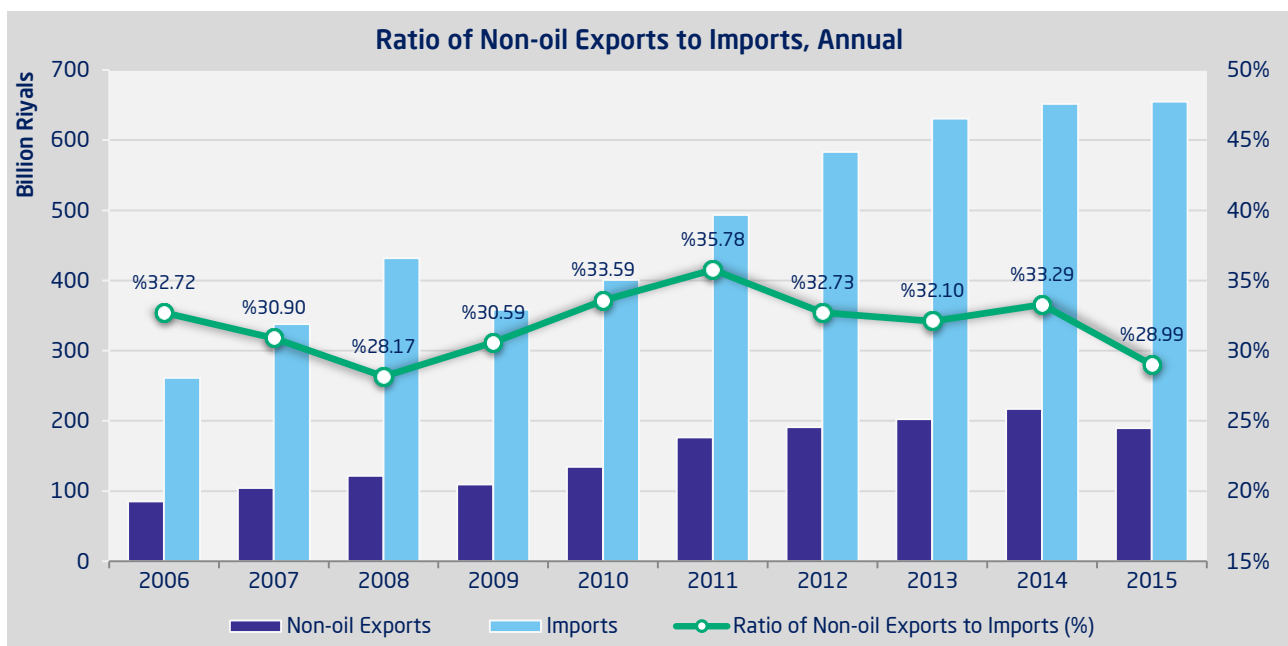




4. Ratio of Non-oil Exports to Imports, Annual

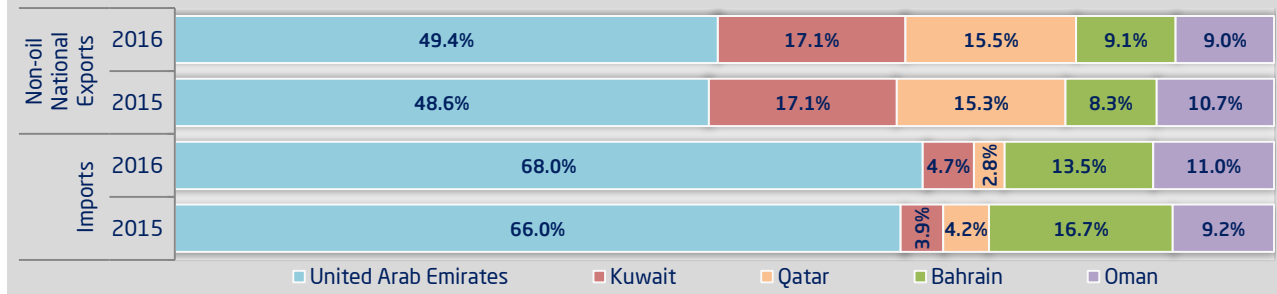
5. Trade between Saudi Arabia and GCC Countries

In the second quarter of 2016, non-oil exports of Saudi Arabia of national origin to GCC countries reached 8434 million riyals as compared to 8348 million riyals in the same period of the previous year, with an increase of 86 million riyals corresponding to 1.0%. Saudi Arabia's imports of goods originated from GCC countries amounted to 10839 million riyals as compared to 14048 million riyals in the same period of the previous year, with a decrease of 3209 million riyals corresponding to 22.8%.

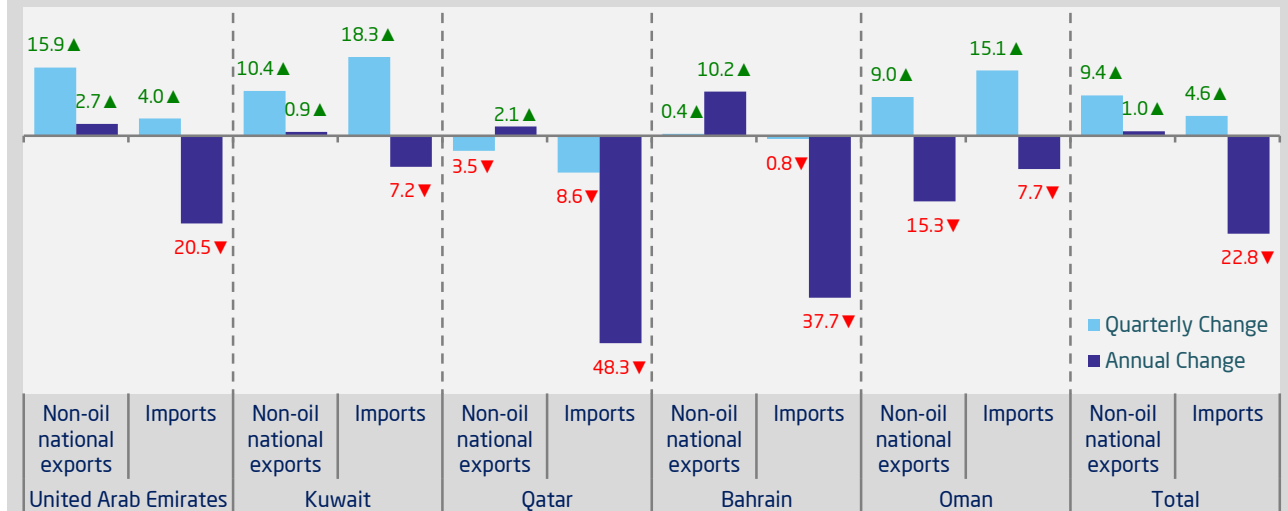
