

# Non-oil exports decrease by 10.8% in 2020

Overall merchandise exports decreased by 33.5% in 2020 compared to 2019. The value of exports amounted to 652.0 billion riyals in 2020, down from 981.0 billion riyals in 2019. This decrease originated mainly from oil exports, which fell by 304.2 billion riyals or 40.5% in the same period. The share of oil exports in total exports, therefore, decreased to 68.7% (2020) from 76.6% (2019).

Non-oil exports decreased by 10.8% in 2020, falling to 204.4 billion riyals from 229.2 billion riyals in 2019. Of the most important non-oil goods, 'Plastics and Rubber and Articles Thereof' (30.7% of non-oil merchandise exports) decreased by 13.9% (10.1 billion riyals) and 'Products of the Chemical or Allied Industries' (28.3% of non-oil merchandise exports) decreased by 16.8% (11.7 billion riyals) from 2019.

Merchandise imports decreased by 9.9% (56.9 billion riyals) in 2020. The value of imports amounted to 517.5 billion riyals in 2020 compared to 574.4 billion riyals in 2019. This decrease was due to the decrease in many sectors compared to 2019, mainly 'Vehicles and Associated Transport Equipment' (29.8%) and 'Machinery and Mechanical Appliances; Electrical Equipment' (9.3%).

### Ratio of Non-oil Exports to Imports decreased to 39.5%

The ratio of non-oil exports to imports decreased to 39.5% in 2020 from 39.9% in 2019, as a result of a lower decrease in imports (9.9%) than in non-oil exports (10.8%) over that period.

### China is Saudi Arabia's main trading partner for merchandise trade

In 2020, exports to China amounted to 120.0 billion riyals, making this country the main destination for exports of Saudi Arabia. Japan and India followed next with 62.3 billion riyals and 60.2 billion riyals, respectively. South Korea, United Arab Emirates, U.S.A, Singapore, Egypt, Bahrain, and the Netherlands were the other countries that ranked in the top 10 destinations. Exports of Saudi Arabia to those 10 countries amounted to 446.0 billion riyals, accounting for 68.4% of the total exports.

Imports from China amounted to 101.6 billion riyals in 2020, making this country the main origin for imports of Saudi Arabia. U.S.A and United Arab Emirates followed next with imports of 55.1 billion riyals and 34.3 billion riyals, respectively. Germany, India, Japan, France, Italy, South Korea, and United Kingdom were the other countries that ranked in the top 10 countries for imports. Imports of Saudi Arabia from those 10 countries amounted to 324.1 billion riyals, accounting for 62.6% of the total imports.



### **Top Five Customs Ports for Imports**

152.7 billion riyals of imports, corresponding to 29.5% of the total, entered the Kingdom from Jeddah Islamic Sea Port in 2020. Among the other major ports of entry for the imports were King Abdulaziz Port (20.4%), King Khalid International Airport (12.6%), Bat'ha (6.2%), and King Fahad International Airport (5.7%). Those five ports together accounted for 74.5% of the total merchandise imports of the Kingdom.

# Methodology

GASTAT's statistics on International trade are built on administrative records from Saudi Customs (non-oil) and the Ministry of Energy (oil). Saudi Arabia's merchandise exports and imports are classified according to the Harmonized Commodity Description and Coding Systems (2017), also known as the Harmonized System (HS), which is maintained by the World Customs Organization (WCO). The HS allows countries to classify traded products in an internationally standardized system of product names and codes. Oil exports refer to exported goods classified in Chapter 27 (mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) of the Harmonized System (HS). Non-oil exports refer to all other goods exported (including petrochemicals).
